
A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. The legislature finds that there is great
3 demand for high quality mental health practitioners in the
4 State, particularly in the aftermath of the coronavirus disease
5 2019. The purpose of this Act is to expand access to high
6 quality mental health services by:

7 (1) Establishing provisional or associate-level licensure
8 requirements and insurance reimbursement allowances
9 for marriage and family therapists, mental health
10 counselors, and psychologists in training;

11 (2) Allowing psychologist license applicants to sit for
12 the licensing examination before completing the
13 supervised experience required for licensure;

14 (3) Allowing the board of psychology to grant licensure
15 waivers for psychologists in certain circumstances;
16 and



1 (4) Authorizing insurance reimbursements for services
2 provided by a supervised social work intern in certain
3 circumstances.

4 PART II

5 SECTION 2. Chapter 451J, Hawaii Revised Statutes, is
6 amended by adding a new section to be appropriately designated
7 and to read as follows:

8 "§451J- Provisional licensure; associate marriage and
9 family therapist; services reimbursable. (a) The department
10 shall grant, upon application and payment of proper fees,
11 provisional licensure as an associate marriage and family
12 therapist to an individual who:

13 (1) Has received a master's degree or doctoral degree from
14 an accredited educational institution in marriage and
15 family therapy or in an allied field related to the
16 practice of mental health counseling that includes or
17 is supplemented by graduate level course work
18 comprising a minimum of thirty-three semester hours,
19 or forty-four quarter hours in the following course
20 areas:



- 1 (A) Marriage and family studies -- nine semester
2 hours or twelve quarter hours;
- 3 (B) Marriage and family therapy studies -- nine
4 semester hours or twelve quarter hours;
- 5 (C) Human development -- nine semester hours or
6 twelve quarter hours;
- 7 (D) Ethical and professional studies -- three
8 semester hours or four quarter hours; and
- 9 (E) Research -- three semester hours or four quarter
10 hours;
- 11 (2) Has completed a one year practicum with three hundred
12 hours of supervised client contact;
- 13 (3) Engages in practice under the clinical supervision of
14 a licensed marriage and family therapist during the
15 period of time necessary to fulfill the clinical
16 experience requirements for licensure as a marriage
17 and family therapist pursuant to section 451J-7(3);
18 provided that the licensed marriage and family
19 therapist is in good standing with the department; and
- 20 (4) Has passed the National Marriage and Family Therapy
21 Exam in accordance with section 451J-8.



1 (b) Each provisional license shall include the name and
2 title of the licensed marriage and family therapist or
3 therapists providing clinical supervision of the applicant as
4 described in subsection (a)(3). A licensed associate marriage
5 and family therapist may only practice marriage and family
6 therapy under the direct supervision of the licensed marriage
7 and family therapist.

8 (c) A provisional license issued pursuant to this section
9 shall be valid for one year from the date of issuance and may be
10 renewed for an additional one-year period if needed to fulfill
11 the requirements for licensure as a marriage and family
12 therapist pursuant to section 451J-7(3).

13 (d) Services provided by a supervised licensed associate
14 marriage and family therapist shall be eligible for insurance
15 reimbursement; provided that the supervising licensed marriage
16 and family therapist's services are eligible for reimbursement
17 as a contracted provider; provided further that the billed rate
18 for the licensed associate marriage and family therapist shall
19 be commensurate with the requisite level of training."

20 SECTION 3. Section 451J-1, Hawaii Revised Statutes, is
21 amended as follows:



1 1. By adding a new definition to be appropriately inserted
2 and to read:

3 "Associate marriage and family therapist" or "licensed
4 associate marriage and family therapist" means a person who:

5 (1) Has completed all educational requirements under
6 section 451J- (a) (1);

7 (2) Has been issued a provisional license under this
8 chapter; and

9 (3) Is currently earning supervised clinical experience in
10 marriage and family therapy under clinical
11 supervision."

12 2. By amending the definition of "clinical supervision" to
13 read:

14 "Clinical supervision" means the supervision of no more
15 than six persons at the same time who are acquiring and
16 completing clinical experience in accordance with [section]
17 sections 451J-7(2) and (3) [7] and 451J- (a) (3), by a licensed
18 marriage and family therapist whose license has been in good
19 standing in any state for two years preceding commencement and
20 during the term of supervision, or any licensed mental health
21 professional whose license has been in good standing in any



1 state and who has been a clinical member in good standing of the
2 association for the two years preceding commencement and during
3 the term of supervision. Clinical supervision includes but is
4 not limited to case consultation of the assessment and diagnosis
5 of presenting problems, development and implementation of
6 treatment plans, and the evaluation of the course of treatment.
7 Clinical supervision may include direct observation by the
8 qualified supervisor of the provision of marriage and family
9 therapy services."

10 3. By deleting the definition of "marriage and family
11 therapy intern".

12 [~~"Marriage and family therapy intern" means a person who
13 has completed all educational requirements stipulated in section
14 451J-7(1)(A) and who is currently earning supervised clinical
15 experience in marriage and family therapy under clinical
16 supervision."~~]

17 SECTION 4. Section 451J-3, Hawaii Revised Statutes, is
18 amended to read as follows:

19 "**§451J-3 Powers and duties of the director.** In addition
20 to any other powers and duties authorized by law, the director
21 may:



- 1 (1) Examine and approve the qualifications of all
2 applicants under this chapter, and issue a license to
3 each successful applicant granting permission to use
4 the title of marriage and family therapist [~~e~~],
5 licensed marriage and family therapist, associate
6 marriage and family therapist, or licensed associate
7 marriage and family therapist in this State pursuant
8 to this chapter and the rules adopted under this
9 chapter;
- 10 (2) Adopt, amend, or repeal rules pursuant to chapter 91;
- 11 (3) Administer, coordinate, and enforce this chapter and
12 rules;
- 13 (4) Discipline a person licensed as a marriage and family
14 therapist or associate marriage and family therapist
15 for any cause described by this chapter, or for any
16 violation of rules, or refuse to license a person for
17 failure to meet licensing requirements or for any
18 cause that would be grounds for disciplining a
19 licensed marriage and family therapist[+] or licensed
20 associate marriage and family therapist; and



1 (5) Appoint an advisory committee of licensed marriage and
2 family therapists and members of the public to assist
3 with the implementation of this chapter and the rules;
4 except that the initial members of the committee who
5 are marriage and family therapists shall not be
6 required to be licensed pursuant to this chapter."

7 SECTION 5. Section 451J-5, Hawaii Revised Statutes, is
8 amended to read as follows:

9 "**§451J-5 Prohibited acts.** Except as specifically provided
10 elsewhere in this chapter, no person shall use the title
11 marriage and family therapist [~~or~~], licensed marriage and family
12 therapist, associate marriage and family therapist, or licensed
13 associate marriage and family therapist without first having
14 secured a license under this chapter. The department shall
15 investigate and prosecute any individual using the title of
16 marriage and family therapist [~~or~~], licensed marriage and family
17 therapist, associate marriage and family therapist, or licensed
18 associate marriage and family therapist without being properly
19 licensed as a marriage and family therapist[~~or~~] or associate
20 marriage and family therapist. Any person who violates this
21 section shall be subject to a fine of not more than \$1,000 per



1 violation. Each day's violation shall be deemed a separate
2 offense. Any action taken to impose or collect the fine imposed
3 under this section shall be a civil action."

4 SECTION 6. Section 451J-6, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "**S451J-6 Exemptions.** (a) Licensure shall not be required
7 of:

- 8 (1) A person doing work within the scope of practice or
9 duties of the person's profession that overlaps with
10 the practice of marriage and family therapy; provided
11 the person does not purport to be a marriage and
12 family therapist [~~or~~], licensed marriage and family
13 therapist[+], associate marriage and family therapist,
14 or licensed associate marriage and family therapist;
15 or
- 16 (2) Any student enrolled in an accredited educational
17 institution in a recognized program of study leading
18 toward attainment of a graduate degree in marriage and
19 family therapy or other professional field; provided
20 that the student's activities and services are part of
21 a prescribed course of study supervised by the



1 educational institution and the student is identified
2 by an appropriate title, including but not limited to
3 "marriage and family therapy student or trainee",
4 "clinical psychology student or trainee", "clinical
5 social work student or trainee", or any title [which]
6 that clearly indicates training status [~~or~~

7 ~~(3) Any individual who uses the title marriage and family~~
8 ~~therapy intern for the purpose of obtaining clinical~~
9 ~~experience in accordance with section 451J-7(3)].~~

10 (b) Nothing in this chapter shall be construed to prevent
11 qualified members of other licensed professions as defined by
12 any law, rule, or the department, including but not limited to
13 social workers, psychologists, registered nurses, or physicians,
14 from doing or advertising that they assist or treat individuals,
15 couples, or families consistent with the accepted standards of
16 their respective licensed professions; provided that no person,
17 unless the person is licensed as a marriage and family
18 therapist [~~or~~] or associate marriage and family therapist, shall
19 use the title of marriage and family therapist [~~or~~], licensed
20 marriage and family therapist [~~or~~], associate marriage and family
21 therapist, or licensed associate marriage and family therapist."



1 SECTION 7. Section 451J-9, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "~~{}~~§451J-9~~{}~~ **Licensure fees.** [~~Licenses~~] Except as
4 otherwise provided in section 451J- , licenses shall be valid
5 for three years and shall be renewed triennially. Any applicant
6 for renewal of a license that has expired within one year of the
7 renewal deadline shall be required to pay a restoration fee in
8 addition to all renewal fees."

9 SECTION 8. Section 451J-10, Hawaii Revised Statutes, is
10 amended by amending subsection (a) to read as follows:

11 "(a) [~~Licenses~~] Except as otherwise provided in section
12 451J- , licenses shall be renewed triennially on or before
13 December 31, with the first renewal deadline occurring on
14 December 31, 2001. Failure to renew a license shall result in a
15 forfeiture of the license. Licenses that have been forfeited
16 may be restored within one year of the expiration date upon
17 payment of renewal and restoration fees, and in the case of
18 marriage and family therapists or licensed marriage and family
19 therapists audited pursuant to subsection (f), documentation of
20 continuing education compliance. Failure to restore a forfeited
21 license within one year of the date of its expiration shall



1 result in the automatic termination of the license. Persons
2 with terminated licenses shall be required to reapply for
3 licensure as a new applicant."

4 SECTION 9. Section 451J-12, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "~~§~~451J-12~~§~~ **Confidentiality and privileged**

7 **communications.** No person licensed as a marriage and family
8 therapist~~§~~ or associate marriage and family therapist, nor any
9 of the person's employees or associates, shall be required to
10 disclose any information that the person may have acquired in
11 rendering marriage and family therapy services except in the
12 following circumstances:

- 13 (1) As required by law;
- 14 (2) To prevent a clear and immediate danger to a person or
15 persons;
- 16 (3) In the course of a civil, criminal, or disciplinary
17 action arising from the therapy where the therapist is
18 a defendant;
- 19 (4) In a criminal proceeding where the client is a
20 defendant and the use of the privilege would violate
21 the defendant's right to a compulsory process of the



1 right to present testimony and witnesses in the
2 defendant's own behalf;
3 (5) In accordance with the terms of a client's previously
4 written waiver of the privilege; or
5 (6) Where more than one person in a family jointly
6 receives therapy and each family member who is legally
7 competent executes a written waiver; in that instance,
8 a marriage and family therapist or associate marriage
9 and family therapist may disclose information received
10 from any family member in accordance with the terms of
11 the person's waiver."

12 SECTION 10. Section 451J-13, Hawaii Revised Statutes, is
13 amended to read as follows:

14 "[~~§~~451J-13~~]~~ **Therapist prohibited from testifying in**
15 **alimony and divorce actions.** If both parties to a marriage have
16 obtained marriage and family therapy by a licensed marriage and
17 family therapist~~[,]~~ or licensed associate marriage and family
18 therapist, the therapist shall be prohibited from testifying in
19 an alimony or divorce action concerning information acquired in
20 the course of therapy. This section shall not apply to custody
21 actions whether or not part of a divorce proceeding."

PART III

SECTION 11. Chapter 453D, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

"§453D- Provisional licensure; associate mental health counselor; services reimbursable. (a) The department shall grant, upon application and payment of proper fees, provisional licensure as an associate mental health counselor to an individual who:

(1) Has received a master's degree or doctoral degree from an accredited educational institution in counseling or in an allied field related to the practice of mental health counseling that includes or is supplemented by graduate level course work in counseling comprising a minimum of forty-eight semester hours or seventy-two quarter hours in the following course areas, with a minimum of three semester hours or five quarter hours in each course area as indicated below:

(A) Human growth and development, including but not limited to the study of life span development, strategies to facilitate that development and



1 transitions, theories of learning and personality
2 development, and human behavior to include
3 crisis, disabilities, addictive behavior, and
4 environmental factors;

5 (B) Social and cultural foundations, including but
6 not limited to the study of issues and trends in
7 a multicultural and diverse society, including
8 characteristics of diverse groups that may
9 include but are not limited to age, race,
10 religious preference, sexual preference, physical
11 disability, ethnicity and culture, gender,
12 socioeconomics, intellectual ability, and
13 individual, family, and group strategies with
14 diverse populations;

15 (C) Counseling theories and applications, including
16 but not limited to counseling and consultation,
17 including both individual and systems
18 perspectives, interviewing, assessment, and
19 counseling skills, as well as applying
20 principles, methods, and theories of counseling,
21 treatment and counseling of mental and emotional



- 1 disorders, and educational techniques aimed at
2 preventing these disorders with individuals and
3 families;
- 4 (D) Group theory and practice, including but not
5 limited to principles of group dynamics, group
6 process, group leadership styles, theories and
7 methods of group counseling, and the application
8 of theory to the group processes;
- 9 (E) Career and lifestyle development, including but
10 not limited to the study of vocational
11 development theories and decision-making models,
12 assessment instruments, and techniques, types,
13 sources, and uses of occupational and educational
14 information systems, career development
15 applications, and career counseling processes,
16 techniques, and resources;
- 17 (F) Appraisal of human behavior, including but not
18 limited to assessment and diagnosis of disorders
19 with an emphasis on categories described in the
20 most recent version of the Diagnostic and
21 Statistical Manual of Mental Disorders and an



1 understanding of these disorders relative to the
2 counseling context;

3 (G) Tests and measurements, including but not limited
4 to theoretical and historical bases for
5 assessment techniques, and assessment methods,
6 including analysis of various types of tests to
7 select, administer, interpret, and use assessment
8 and evaluation instruments and techniques in
9 counseling;

10 (H) Research and program evaluation, including but
11 not limited to research design and methods,
12 statistical analysis, principles, practices, and
13 application of needs assessment, and program
14 evaluation;

15 (I) Professional orientation and ethics, including
16 but not limited to the history of the helping
17 profession, professional roles and functions,
18 ethical standards, confidentiality, professional
19 organizations, and the public policy process,
20 including advocacy on behalf of the profession
21 and its clientele; and



1 (J) At least two academic terms of supervised mental
2 health practicum intern experience for graduate
3 credit of at least six semester hours or ten
4 quarter hours in a mental health counseling
5 setting, with a total of three hundred hours of
6 supervised client contact. The practicum
7 experience shall be completed under the clinical
8 supervision of a person who is licensed as a
9 mental health counselor, psychologist, clinical
10 social worker, advanced practice registered nurse
11 with a specialty in mental health, marriage and
12 family therapist, or physician with a specialty
13 in psychiatry;

14 (2) Engages in practice under the clinical supervision of
15 a licensed mental health counselor during the period
16 of time necessary to fulfill the necessary
17 requirements for licensure as a mental health
18 counselor pursuant to section 453D-7; provided that
19 the licensed mental health counselor is in good
20 standing with the department; and



1 (3) Has passed the National Counselor Examination for
2 Licensure and Certification in accordance with section
3 453D-9.

4 (b) Each provisional license shall include the name and
5 title of the licensed mental health counselor or therapists
6 providing clinical supervision of the applicant as described in
7 subsection (a) (2). A licensed associate mental health counselor
8 may only practice mental health counseling under the direct
9 supervision of the licensed mental health counselor.

10 (c) A provisional license issued pursuant to this section
11 shall be valid for one year from the date of issuance and may be
12 renewed for an additional one-year period if needed to fulfill
13 the requirements for licensure as a mental health counselor
14 pursuant to section 453D-7(2).

15 (d) Services provided by a supervised licensed associate
16 mental health counselor shall be eligible for insurance
17 reimbursement; provided that the supervising licensed mental
18 health counselor's services are eligible for reimbursement as a
19 contracted provider; and provided further that the billed rate
20 for the licensed associate mental health counselor is
21 commensurate with the requisite level of training."



1 SECTION 12. Section 453D-1, Hawaii Revised Statutes, is
2 amended as follows:

3 1. By adding a new definition to be appropriately inserted
4 and to read:

5 ""Associate mental health counselor" or "licensed associate
6 mental health counselor" means a person who:

7 (1) Has completed all education requirements under section
8 453D- (a) (1);

9 (2) Has been issued a provisional license under this
10 chapter; and

11 (3) Is currently earning supervised clinical experience in
12 mental health counseling under clinical supervision."

13 2. By amending the definition of "clinical supervision" to
14 read:

15 ""Clinical supervision" means supervision applied to all
16 individuals who are gaining the experience required for a
17 license as a mental health counselor[-] or associate mental
18 health counselor. "Clinical supervision" includes but is not
19 limited to:

20 (1) Case consultation on the assessment and presenting
21 problem;



- 1 (2) Development and implementation of treatment plans;
- 2 (3) Enhancement of the supervisee's counseling techniques
- 3 and treatment evaluation skills; and
- 4 (4) Evaluation of the course of treatment."

5 SECTION 13. Section 453D-3, Hawaii Revised Statutes, is
6 amended to read as follows:

7 "[+]§453D-3[+] **Powers and duties of the director.** In
8 addition to any other powers and duties authorized by law, the
9 director shall have the powers and duties to:

- 10 (1) Grant permission to a person to use the title of
11 "licensed mental health counselor" or "licensed
12 associate mental health counselor" or a description
13 indicating one is a licensed mental health counselor
14 or licensed associate mental health counselor in this
15 State pursuant to this chapter and the rules adopted
16 pursuant thereto;
- 17 (2) Adopt, amend, or repeal rules pursuant to chapter 91
18 as the director finds necessary to carry out this
19 chapter;
- 20 (3) Administer, coordinate, and enforce this chapter;



1 (4) Discipline a licensed mental health counselor or
2 licensed associate mental health counselor for any due
3 cause described by this chapter or violation of the
4 rules;

5 (5) Refuse to license a person for failure to meet
6 licensing requirements or on grounds sufficient to
7 discipline a licensed mental health counselor~~[+]~~ or
8 licensed associate mental health counselor; and

9 (6) Appoint an advisory committee consisting of licensed
10 mental health counselors and members of the public to
11 assist with the implementation of this chapter and
12 adopted rules; provided that the initial members of
13 the committee who are mental health counselors shall
14 not be required to be licensed pursuant to this
15 chapter."

16 SECTION 14. Section 453D-5, Hawaii Revised Statutes, is
17 amended to read as follows:

18 "[~~f~~]~~S~~**453D-5**[~~+~~] **Prohibited acts.** Except as specifically
19 provided in this chapter, no person shall engage in the practice
20 of mental health counseling or use the title of "licensed mental
21 health counselor" [~~e~~], "mental health counselor", "licensed



1 associate mental health counselor", or "associate mental health
2 counselor" without a valid license issued under this chapter.
3 Any person who violates this section shall be subject to a fine
4 of not more than \$1,000 for each separate offense. Each day of
5 each violation shall constitute a separate offense. Any action
6 taken to impose or collect the fine imposed under this section
7 shall be a civil action."

8 SECTION 15. Section 453D-6, Hawaii Revised Statutes, is
9 amended by amending subsection (a) to read as follows:

10 "(a) This chapter shall not apply to:

11 (1) A person doing work within the duties of the person's
12 profession that overlaps with the practice of mental
13 health counseling; provided that no [~~such~~] person
14 shall use a title stating or implying that the person
15 is a "licensed mental health counselor" [~~or~~], "mental
16 health counselor", "licensed associate mental health
17 counselor", or "associate mental health counselor" or
18 describe or refer to the person's services as mental
19 health counseling;

20 (2) Any person who is a duly recognized member of the
21 clergy; provided that the person functions only within



1 the person's capacity as a member of the clergy; ~~and~~
2 provided further that the person does not represent
3 the person to be a "licensed mental health counselor"
4 ~~or~~, "mental health counselor", "licensed associate
5 mental health counselor", or "associate mental health
6 counselor" or describe or refer to the person's
7 services as mental health counseling;

- 8 (3) Any student enrolled in an accredited educational
9 institution in a recognized program of study leading
10 towards attainment of a graduate degree in mental
11 health counseling or other professional field;
12 provided that the student's activities and services
13 are part of a prescribed course of study supervised by
14 the accredited educational institution and the student
15 is identified by an appropriate title, including but
16 not limited to "mental health counseling student" or
17 "trainee", "clinical psychology student" or "trainee",
18 "social work student" or "trainee", "marriage and
19 family counseling student" or "trainee", or any title
20 that clearly indicates training status;



1 ~~[(4) Any individual who uses the title of "mental health~~
2 ~~counselor intern" for the purpose of obtaining~~
3 ~~clinical experience in accordance with section 453D-~~
4 ~~7(a)(2);~~

5 ~~(5)]~~ (4) Any person employed by a federal, state, or
6 county government agency in a counseling position, but
7 only at those times when the employee is carrying out
8 the duties and responsibilities as a counselor in
9 governmental employment; or

10 ~~[(6)]~~ (5) Any person who is obtaining supervised clinical
11 experience for licensure as a psychologist, social
12 worker, marriage and family therapist, or as another
13 licensed professional; provided that the person's
14 title indicates a trainee or intern status; and
15 provided further that the person does not purport to
16 be a "licensed mental health counselor" ~~[or]~~, "mental
17 health counselor" ~~[or]~~, "licensed associate mental
18 health counselor", or "associate mental health
19 counselor".

20 SECTION 16. Section 453D-10, Hawaii Revised Statutes, is
21 amended to read as follows:



1 "~~+~~§453D-10~~+~~ **Licensure; fees.** A license shall be
2 issued to a person deemed to be qualified under ~~[section]~~
3 sections 453D- or 453D-7 upon the payment of a license fee to
4 be determined by the department and shall be valid for three
5 years~~-~~; provided that provisional licenses shall be valid for
6 one year."

7 SECTION 17. Section 453D-11, Hawaii Revised Statutes, is
8 amended to read as follows:

9 "~~+~~§453D-11~~+~~ **Renewal of license; fees.** [~~Licenses~~]
10 Except as otherwise provided in section 453D- , licenses shall
11 be renewed, upon the payment of a renewal fee, triennially not
12 earlier than ninety days before June 30, with the first renewal
13 deadline occurring on June 30, 2008. Failure to renew a license
14 shall result in a forfeiture of the license. Licenses that have
15 been forfeited may be restored within one year of the expiration
16 date upon payment of renewal and restoration fees. Failure to
17 restore a forfeited license within one year of the date of its
18 expiration shall result in the automatic termination of the
19 license and the person may be required to reapply for licensure
20 as a new applicant. All renewal and restoration fees shall be
21 determined by the department."



1 SECTION 18. Section 453D-13, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "[+]§453D-13[+] **Confidentiality and privileged**
4 **communications.** No person licensed as a mental health
5 counselor[7] or associate mental health counselor, nor any of
6 the person's employees or associates, shall be required to
7 disclose any information that the person may have acquired in
8 rendering mental health counseling services, except in the
9 following circumstances:

- 10 (1) As required by law;
- 11 (2) To prevent a clear and imminent danger to a person or
12 persons;
- 13 (3) In accordance with the terms of a previously written
14 waiver of the privilege where the waiver is executed
15 by the client or by the client's legally recognized
16 representative;
- 17 (4) Where more than one person jointly receives counseling
18 and each person who is legally competent executes a
19 written waiver. In that instance, a mental health
20 counselor may disclose information from any person in
21 accordance with that person's waiver; or



1 (5) In the course of a disciplinary action or pursuant to
2 a duly authorized subpoena issued by the department."
