A BILL FOR AN ACT

RELATING TO THE BOARD OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that teachers and school							
2	administrators are essential to student success. Yet, the board							
3	of education currently consists of nine voting members, none of							
4	whom are required to be a public school teacher or public school							
5	administrator.							
6	The legislature further finds that the board of education							
7	would benefit from the perspective of a public school teacher							
8	representative and public school administrator representative by							
9	providing insight into the:							
10	(1) Educational and professional climate in Hawaii's							
11	public schools;							
12	(2) Impact of education policies on teacher recruitment							
13	and retention; and							
14	(3) Resources needed to deliver a quality learning							
15	experience to all of Hawaii's children.							
16	The legislature additionally finds that the coronavirus							
17	disease 2019 pandemic (COVID-19) has significantly disrupted

1 Hawaii's public education system, forcing schools to adapt their 2 operations to protect public health. School communities were 3 required to adopt new protocols to deliver instructional 4 content, including comprehensive distance learning programs. 5 Board of education members and school administrators were also 6 responsible for using medical information to make decisions 7 about school safety, such as when school campuses could safely 8 reopen and welcome the return of faculty and students. Board of 9 education deliberations about protocols and service delivery 10 systems developed in response to COVID-19 would have benefited 11 from the experience of a public school teacher representative 12 and public school administrator representative, given that 13 teachers spearhead classes and directly interact with students 14 and parents.

15 The purpose of this Act is to require the board of 16 education to invite:

17 (1) The exclusive representative for bargaining unit (5)
18 to appoint a nonvoting public school teacher
19 representative to the board; and

4	SECTION 2. Section 302A-121, Hawaii Revised Statutes, is							
5	amended to read as follows:							
6	"[{]§302A-121[}] Board of education; members; student							
7	[and], military, teacher, and administrator representatives.							
8	(a) The	board shall consist of nine members as follows:						
9	(1)	One member from the county of Hawaii;						
10	(2)	One member from the county of Maui;						
11	(3)	One member from the county of Kauai;						
12	(4)	Three members from the city and county of Honolulu;						
13		and						
14	(5)	Three at-large members; provided that the governor						
15		shall select an at-large member as the chairperson.						
16	The members shall be appointed by the governor, with the advice							
17	and consent of the senate. The governor may remove or suspend							
18	for cause any member of the board.							
19	(b)	Pursuant to article XVIII, section 12, of the Hawaii

1 the appointed board shall be as determined in section 21 of Act 2 5, Session Laws of Hawaii 2011. 3 (c) The members of the board shall serve without pay but shall be entitled to reimbursement for necessary expenses, 4 5 including travel and board and lodging expenses, while attending 6 meetings of the board or when actually engaged in business 7 relating to the work of the board. 8 (d) Pursuant to section 302A-447, the state student 9 council shall select a nonvoting public high school student 10 representative to the board. 11 (e) Pursuant to section 302A-1101(c), the board shall 12 invite the senior military commander in Hawaii to appoint a 13 nonvoting military representative to the board. 14 The board shall invite the exclusive representative (f) 15 for bargaining unit (5) to appoint a nonvoting public school 16 teacher representative to the board. 17 (g) The board shall invite the exclusive representative 18 for bargaining unit (6) to appoint a nonvoting public school 19 administrator representative to the board." 20 SECTION 3. Statutory material to be repealed is bracketed 21 and stricken. New statutory material is underscored.
