# A BILL FOR AN ACT

RELATING TO CESSPOOLS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there are 2 approximately eighty-three thousand cesspools across the State, 3 with 48,596 on Hawaii island, 14,300 on Kauai, 11,038 on Maui, 4 7,491 on Oahu, and 1,400 on Molokai. Pursuant to Act 125, 5 Session Laws of Hawaii 2017, every cesspool in the State, 6 excluding cesspools granted exemptions by the director of 7 health, must be upgraded or converted to a director of health-8 approved wastewater system or connected to a sewerage system by 9 January 1, 2050.

10 Additionally, the legislature also finds that because many 11 cesspools will need to be converted each year, planning and 12 coordination need to occur between state and county agencies, 13 communities and residents affected, and those involved in the 14 replacement of cesspools to ensure an adequate supply of 15 materials, workers, and equipment as demand to convert 16 increases.

1 The legislature further finds that the counties are 2 responsible for wastewater management and are in the best 3 position to identify priority neighborhoods that are conducive to connection to an existing or proposed wastewater treatment 4 5 system; conduct necessary public outreach to communicate to 6 affected residents; conduct appropriate feasibility studies; 7 plan, design, and construct wastewater connections and 8 improvements; and implement user connection and monthly billing 9 fees.

10 As such, the legislature additionally finds that creating a 11 pilot program that provides upfront planning funds might 12 encourage the counties to identify the most feasible 13 neighborhoods to connect to an existing or future wastewater 14 treatment plant, engage communities in the discussion, conduct 15 preliminary engineering, and estimate upfront and ongoing costs. 16 A successful pilot program could provide the necessary data and 17 plans to assist the counties to implement wastewater connections 18 and scale future programs to ensure cesspools are converted by 19 2050.

Therefore, the purpose of this Act is to:



1 Establish a pilot program within the environmental (1)2 management division of the department of health to 3 work with each county to identify a priority area to expand the county sewerage system or other centralized 4 5 treatment system to connect individual properties in the priority area and reduce or eliminate cesspools in 6 7 the identified area; and 8 (2) Appropriate funds to the department of health to 9 provide planning grants to each county for a pilot 10 cesspool conversion project. 11 SECTION 2. (a) There is established a pilot program 12 within the environmental management division of the department 13 of health to work with the four counties to: 14 (1) Identify a priority area in each county to expand the 15 county sewerage system or other centralized treatment 16 system to connect individual properties in the 17 priority area and reduce or eliminate cesspools in the 18 identified area; 19 (2) Meet with appropriate community stakeholders and 20 homeowners to gather input regarding plans for the 21 pilot project;

1	(3)	Conduct planning and design;
2	(4)	Estimate capital and ongoing maintenance costs; and
3	(5)	Equitably allocate the funds available to each county
4		to carry out the pilot project.
5	(b)	Each county shall submit a report on the progress made
6	on priori	ty areas to convert or upgrade cesspools to a director
7	of health	a-approved wastewater system to the legislature no later
8	than twer	ity days prior to the convening of the regular sessions
9	of 2024,	2025, and 2026. The report shall include:
10	(1)	The location, costs of the cesspool conversion
11		project, and number of homes or units assisted;
12	(2)	Outreach efforts conducted with community stakeholders
13		and homeowners on the pilot project;
14	(3)	Status of planning and design;
15	(4)	Estimated capital and maintenance expenses and
16		potential sources of revenues to construct projects;

18	(5)	Recommendations for future priority areas suitable for
19		municipal sewer connections to further eliminate
20		cesspools in their counties.

(c) The pilot program shall cease to exist on June 30,
 2026.

3 (d) As used in this section, "cesspool" has the same
4 meaning as in section 342D-72, Hawaii Revised Statutes.

5 SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$10,000,000 or so 6 7 much thereof as may be necessary for fiscal year 2023-2024 and 8 the same sum or so much thereof as may be necessary for fiscal 9 year 2024-2025 for the establishment of a pilot program within 10 the environmental management division of the department of 11 health to work with each county to identify a priority area to expand the county sewerage system or other centralized treatment 12 system to connect individual properties in the priority area and 13 14 reduce or eliminate cesspools in the identified area. The 15 environmental management division of the department of health 16 may obtain contractor support to provide any services required 17 to establish and implement the pilot program.

18 The sums appropriated shall be expended by the department19 of health for the purposes of this Act.

SECTION 4. This Act shall take effect on July 1, 2023.
