Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2581, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO EMERGENCY MANAGEMENT,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to remove the ability of the Governor or a mayor to suspend electronic media transmission during a state of emergency or local state of emergency, respectively.




that it pass Final Reading in the form attached hereto as H.B.
No. 2581, H.D. 1, S.D. 1, C.D. 1.





