Your Committee on Higher Education & Technology, to which was referred H.C.R. No. 152 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE HAWAII TOURISM AUTHORITY, IN CONSULTATION WITH THE OFFICE OF ENTERPRISE TECHNOLOGY SERVICES, TO CONDUCT A STUDY ON THE SOCIAL AND SAFETY IMPACTS OF GEOTAGGING,"


