A BILL FOR AN ACT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 291-14, Hawaii Revised Statutes, is amended as follows:

1 "(c) No operator of any pickup truck may operate the 2 vehicle with any passenger [twelve years of age or under] in the 3 bed or load-carrying area of the vehicle, unless one of the 4 following applies: 5 (1) An emergency exists that threatens the life of the 6 passenger being transported in the bed or load-7 carrying area of the vehicle; or 8 (2) The vehicle is being operated in parades, caravans, or 9 exhibitions [which] that are officially authorized or 10 otherwise permitted by law. 11 Any person who violates this section shall be subject (d) 12 to a fine of \$25 for each violation [, provided that any person 13 who violates subsection (c) shall be subject to a fine of \$50 14 for each separate violation]." 15 SECTION 2. JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO TRUCK BEDS.

- PURPOSE: To repeal several exemptions from the prohibition on operating a pickup truck with a passenger seated in the bed or loadcarrying area, including the exemption that allows passengers over twelve years of age to ride in the bed or load-carrying area.
- MEANS: Amend section 291-14(a), (c), and (d), Hawaii Revised Statutes.
- JUSTIFICATION: Cargo areas of motor vehicles with beds, commonly known as pickup trucks, are not designed to transport occupants. When involved in a crash an occupant seated in the cargo area of a pickup truck can be thrown from the bed of the pickup truck and sustain serious injuries or worse.

According to Fatal Analysis Reporting System, from 2015 through 2019, there were two roadway crashes that resulted in four fatalities on our roadways due to the victims riding in the bed of a truck.

<u>Impact on the public</u>: This bill will lessen the impact on occupants involved in crashes.
