A BILL FOR AN ACT

RELATING TO CIVIC ENGAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that civic engagement 2 provides an opportunity for residents to become involved with 3 improving their local communities and neighborhoods. In 2021, 4 the Hawaii supreme court enacted Rule 23 to establish the 5 commission to promote and advance civic education (PACE 6 commission). One of the main functions of the PACE commission 7 is to provide leadership, oversight, and initiatives to increase 8 civic education in the community and at schools, increase 9 citizens' knowledge about government, and promote informed 10 participation in government and democracy in the State.

11 The legislature further finds that the public access room, 12 an office under the legislative reference bureau, provides the 13 public with information, equipment, facilities, and services to 14 assist in research activities, educational outreach, and public 15 engagement related to work with the legislature. The 16 legislature additionally finds that the public access room is 17 well-positioned to further civic engagement between the

legislature and students in the State through educational
partnerships, such as the Hawaii P-20 partnerships for
education. However, the public access room currently lacks
resources to provide outreach services beyond its current
efforts.

6 In addition, the legislature finds that civic education 7 prepares students to participate in the public and political lives of their communities. Teaching students about the 8 9 importance of civic engagement through civic education helps 10 develop critical thinking skills that are vital to the functioning of a democratic nation, including how to recognize 11 12 social problems, evaluate possible solutions to problems, 13 separate evidence-based claims from opinions, and act upon what 14 is learned.

15 The legislature further finds that according to the US 16 Elections Project, in the 2022 general election, forty-four 17 states had a higher voter turnout percentage than Hawaii. The 18 legislature also finds that cultivating social and political 19 engagement among students through civic education is an 20 important strategy to increase voter turnout and citizen 21 engagement over the long term.

1 The legislature additionally finds that in 2018, the board 2 of education adopted the Hawaii core standards in social 3 studies. These core standards outline the content, concepts, 4 and inquiry skills students need to reason, wonder, and think 5 about the vastness and richness of the human condition. The 6 Hawaii core standards in social studies also integrate and 7 encompass the democratic values, civility, and global 8 perspective needed to support the development of critical 9 thinking and habits of mind that are the hallmark of a mature, 10 community-minded citizen. The standards are also premised upon a rigorous and relevant K-12 social studies experience. 11 12 However, the legislature finds that the department of education 13 has not engaged in systematic teacher training on the new 14 standards or addressed the paucity of culturally appropriate materials for historical and civic education. 15 16 Accordingly, the purpose of this Act is to: 17 Require the public access room to establish and (1)maintain an outreach and engagement program for 18 primary, secondary, post-secondary, and community 19 20 education and provide funding for one full-time

1 establish one full-time equivalent (1.0 FTE) position within the 2 public access room.

3 The sum appropriated shall be expended by the legislative4 reference bureau for the purposes of this Act.

5 SECTION 6. There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$ or so 7 much thereof as may be necessary for fiscal year 2024-2025 for 8 the expansion of civic education in public schools, including 9 professional development and classroom resources related to the 10 Hawaii core standards in social studies, and the establishment 11 of two full-time equivalent (2.0 FTE) permanent civic education 12 resource teacher positions.

13 The sum appropriated shall be expended by the department of14 education for the purposes of this Act.

15 SECTION 7. In accordance with section 9 of article VII of 16 the Hawaii State Constitution and sections 37-91 and 37-93, 17 Hawaii Revised Statutes, the legislature has determined that the 18 appropriations contained in H.B. No. , will cause the state 19 general fund expenditure ceiling for fiscal year 2024-2025 to be 20 exceeded by \$ or per cent. In addition, the 21 appropriations contained in this Act will cause the general fund

3	amount of general fund appropriations contained in only these
4	two Acts will cause the state general fund expenditure ceiling
5	for fiscal year 2024-2025 to be exceeded by
6	\$ or per cent. The reasons for exceeding the
7	general fund expenditure ceiling are that:
8	(1) The appropriations made in this Act are necessary to
9	serve the public interest; and
10	(2) The appropriations made in this Act meet the needs
11	addressed by this Act.
12	SECTION 8. New statutory material is underscored.
13	SECTION 9. This Act shall take effect on July 1, 2024.

Requires the public access room to establish and maintain an outreach and engagement program for primary, secondary, postsecondary, and community education. Requires the department of education and university of Hawaii to assign appropriate staff to coordinate with the public access room for the outreach and engagement program. Establishes two full-time equivalent permanent civic education resource teacher positions. Appropriates funds to the legislative reference bureau for one full-time equivalent (1.0 FTE) position to assist in effectuating this requirement. Appropriates funds to the department of education for the expansion of civic education in the public schools.
