H.B. NO. 2545

### A BILL FOR AN ACT

RELATING TO AGRICULTURAL INFRASTRUCTURE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that reliable 2 agricultural infrastructure is the lifeline of Hawaii's 3 agriculture industry. To ensure that the State's crops receive 4 a steady and dependable supply of water, sufficient funding is 5 needed to maintain and improve Hawaii's irrigation systems. 6 Additionally, funding to develop agricultural land resources 7 provides much needed accessibility and support infrastructure to 8 allow local producers to become financially viable. Increasing 9 drought events, severe thunderstorms, flash flooding, wildfires, 10 and other crises have highlighted the need for timely repair and 11 maintenance of the State's agricultural infrastructure while 12 also developing new, innovative opportunities for growth in the 13 industry.

14 The purpose of this Act is to finance the repair and15 maintenance of the State's agricultural infrastructure.

16 SECTION 2. The director of finance is authorized to issue 17 general obligation bonds in the sum of \$71,700,000 or so much
