SECTION 1. (a) The Hawaii public housing authority shall

 pilot program for youth tenants in public housing. The pilot
 program shall:

3 The Hawaii public housing authority shall submit: (c) 4 (1) An interim report to the legislature on the status of 5 the pilot program no later than twenty days prior to 6 the convening of the regular session of 2025; and 7 A final report of its findings and recommendations, (2) 8 including any proposed legislation, no later than 9 twenty days prior to the convening of the regular 10 session of 2026.

SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2024-2025 for the implementation of the recreation and education upward mobility pilot program for youth tenants in public housing, including all program costs.

17 The sum appropriated shall be expended by the Hawaii public18 housing authority for the purposes of this Act.

19 SECTION 3. There is appropriated out of the general 20 revenues of the State of Hawaii the sum of \$ or so 21 much thereof as may be necessary for fiscal year 2024-2025 for

6 The sum appropriated shall be expended by the Hawaii public7 housing authority for the purposes of this Act.

8 SECTION 4. In accordance with section 9 of article VII of 9 the Hawaii State Constitution and sections 37-91 and 37-93, 10 Hawaii Revised Statutes, the legislature has determined that the 11 appropriations contained in H.B. No. , will cause the state general fund expenditure ceiling for fiscal year 2024-2025 to be 12 13 per cent. In addition, the exceeded by \$ or 14 appropriation contained in this Act will cause the general fund 15 expenditure ceiling for fiscal year 2024-2025 to be further 16 exceeded by \$ or per cent. The combined total 17 amount of general fund appropriations contained in only these two Acts will cause the state general fund expenditure ceiling 18 19 for fiscal year 2024-2025 to be exceeded by
