# A BILL FOR AN ACT

RELATING TO ENERGY ASSISTANCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii's electricity 2 rates are among the highest in the nation, at close to three 3 times the national average, and vary based on availability of 4 renewable resources, power plants, fuel costs, and pricing 5 regulations. The 2022 report commissioned by the Aloha United 6 Way, "ALICE in Hawaii: 2022 Facts and Figures", states that forty-four per cent of households in the State live below the 7 8 ALICE (asset limited, income constrained, employed) threshold, 9 meaning that almost half of all families in Hawaii are 10 struggling to make ends meet, even though they are employed. 11 The number of electric utility customers in arrears and facing 12 disconnection is higher than before the COVID-19 pandemic, with thousands of customers collectively owing millions of dollars. 13 14 In addition, electricity needs are expected to increase due to 15 rising climate temperatures and associated home cooling needs. During the Regular Session of 2022, the legislature adopted 16

Senate Concurrent Resolution No. 242, S.D. 1, that requested the

1 creation of a Hawaii state low-income home energy assistance 2 program (LIHEAP) working group. As noted in a December 2022 3 report to the legislature submitted by the public utilities 4 commission, the federal LIHEAP administered by the department of human services, a program designed to provide energy assistance 5 6 to families, served fewer than nine thousand households in 7 Hawaii in 2020, or about two per cent of the State's population 8 potentially eliqible for energy assistance based on income. The 9 State received the lowest amount of federal funding for federal 10 LIHEAP of all states in fiscal year 2021-2022. According to 11 estimates from the National Energy and Utility Affordability 12 Coalition, Hawaii received 0.14 per cent of federal LIHEAP funds 13 in fiscal year 2021-2022, roughly half of the next-lowest state. 14 Funding for states is determined based on a formula developed in 15 1984, which inherently favors states with large heating needs and does not consider specific electricity prices within states. 16

17 The legislature further finds that in addition to the 18 limited financial assistance available through the department of 19 human services from the federal LIHEAP program, the public 20 utilities commission public benefits administrator plays a vital 21 role in ensuring that all available State and federal benefits

and rebate programs are being utilized by providing
 opportunities and solutions for Hawaii residents and business to
 save money and energy. The legislature also finds that the
 State must commit to efforts that provide assistance to low income households that are directly impacted due to the high
 cost of electricity.

7 The purpose of this Act is to establish within the 8 department of human services a Hawaii home energy assistance 9 program similar to the federal LIHEAP program that will allow 10 the department of human services to provide energy assistance to more families. In addition to financial assistance from the 11 12 department of human services, recipients of the Hawaii home 13 energy assistance program will receive valuable information and assistance from the public utilities commission public benefits 14 15 administrator about making their homes more energy efficient to reduce their cost of electricity. 16

SECTION 2. Chapter 346, Hawaii Revised Statutes, is
amended by adding two new sections to part II to be
appropriately designated and to read as follows:

#### 20 "<u>§346-</u> Hawaii home energy assistance program;

21 established. (a) There is established within the department

8	(b) The public utilities commission public benefits
9	administrator, in consultation with the department, shall
10	provide information and technical assistance to recipients,
11	including an energy audit at the request of a recipient, and
12	assist recipients with implementation of energy efficiency
13	improvements, in accordance with section 269-123(b).
14	(c) The department shall adopt rules pursuant to chapter
15	91 for purposes of this section.

17	<b>fund.</b> (a) There is established in the state treasury the
18	Hawaii home energy assistance program special fund, to be
19	administered by the department, into which shall be deposited:
20	(1) Appropriations made by the legislature;

10	purposes	of the Hawaii home energy assistance program under
11	section 3	<u>46-</u> ."
12	SECT	ION 3. Section 269-123, Hawaii Revised Statutes, is
13	amended b	y amending subsection (b) to read as follows:
14	"(b)	The public benefits fee administrator's duties and
15	responsib	ilities shall be established by the public utilities
16	commissio	n by rule or order, and may include:
17	(1)	Identifying, developing, administering, promoting,
18		implementing, and evaluating programs, methods, and
19		technologies that support energy-efficiency and
20		demand-side management programs;

1 contract for services for the purposes of implementing the 2 Hawaii home energy assistance program. 3 The sum appropriated shall be expended by the department of 4 human services for the purposes of this Act. 5 SECTION 5. There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2024-2025 to be 7 8 deposited into the Hawaii home energy assistance program special fund. 9 10 SECTION 6. There is appropriated out of the Hawaii home 11 energy assistance program special fund the sum of \$ or 12 so much thereof as may be necessary for fiscal year 2024-2025 13 for the purposes of the Hawaii home energy assistance program. 14 The sum appropriated shall be expended by the department of human services for the purposes of this Act. 15 16 SECTION 7. In accordance with section 9 of article VII of 17 the Hawaii State Constitution and sections 37-91 and 37-93, 18 Hawaii Revised Statutes, the legislature has determined that the appropriations contained in H.B. No. , will cause the state 19 20 general fund expenditure ceiling for fiscal year 2024-2025 to be exceeded by \$ or per cent. In addition, the 21

1	appropriations contained in this Act will cause the general fund
2	expenditure ceiling for fiscal year 2024-2025 to be further
3	exceeded by \$ or per cent. The combined total
4	amount of general fund appropriations contained in only these
5	two Acts will cause the state general fund expenditure ceiling
6	for fiscal year 2024-2025 to be exceeded by
7	\$ or per cent. The reasons for exceeding the
8	general fund expenditure ceiling are that:
9	(1) The appropriations made in this Act is necessary to
10	serve the public interest; and
11	(2) The appropriations made in this Act meets the needs
12	addressed by this Act.
13	SECTION 8. Statutory material to be repealed is bracketed
14	and stricken. New statutory material is underscored.
15	SECTION 9. This Act shall take effect on July 1, 3000.
