A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that recent corruption 2 discovered at state and county agencies cannot be tolerated. 3 Preventing corruption requires transparency and accountability 4 to ensure public agencies are effective, efficient, and 5 successfully provide services in the public interest. The 6 legislature further finds that the department of transportation 7 manages and spends more taxpayer dollars than nearly any other 8 state agency. Most departments of transportation throughout the 9 country have robust mechanisms to prevent corruption and 10 mismanagement, including publicly transparent processes to 11 evaluate, select, and track projects; oversight commissions of 12 expert stakeholders to independently monitor, evaluate, and 13 provide guidance to the department and policymakers; and regular 14 robust reporting that meaningfully measures and assesses overall progress toward public policy goals. However, similar 15 16 mechanisms to prevent corruption or mismanagement at Hawaii's 17 department of transportation do not currently exist.

1 In addition to preventing corruption, robust transparency 2 and accountability are necessary to ensure that the state 3 government provides effective and efficient services in the 4 public interest. Unfortunately, Hawaii currently has among the 5 worst traffic fatality rates in the country, including the 6 nation's highest senior citizen pedestrian fatality rate. 7 Hawaii also has among the worst traffic congestion in the 8 country and among the highest cost of transportation, which 9 greatly increases the cost of living for residents in rural and 10 urban areas alike.

Accordingly, the purpose of this Act is to help the department of transportation prevent corruption and improve transportation outcomes by establishing mechanisms enabling basic transparency and accountability for transportation efforts by:

16 (1) Requiring transparency in transportation project
17 evaluation, selection, and tracking; and
18 (2) Adding to the mission of the state highway safety
19 council to make the council an independently led group
20 of expert stakeholders that may review the
21 department's work to ensure transparency and provide

1	guidance to the department and legislature to help
2	achieve state goals and outcomes.
3	SECTION 2. Section 286-5, Hawaii Revised Statutes, is
4	amended to read as follows:
5	"§286-5 State highway safety and modernization council.
6	(a) There is established within the department of
7	transportation for administrative purposes the Hawaii highway
8	safety and modernization council. [The director of
9	transportation shall serve as its chairperson.] The council
10	shall be chaired on an annually rotating basis between the
11	chairpersons of the respective committees of the house of
12	representatives and senate having jurisdiction over
13	transportation, or their designees. The following or their
14	designated representatives shall be members of the council: the
15	chief justice, the attorney general, the director of health,
16	the superintendent of education, the chairperson and executive
17	director of the charter school commission, the [president]
18	<u>chairperson</u> of the University of Hawaii[$ au$] <u>at Manoa department</u>
19	of urban and regional planning, the co-chairpersons of the
20	Hawaii climate change mitigation and adaptation commission, the
21	director of the office of planning and sustainable development,

13	<u>(b)</u>	The state highway safety and modernization council
14	shall [ad	vise]:
15	(1)	Ensure transparency and oversight in programs,
16		projects, decisions, and spending related to ground
17		transportation in the department of transportation;
18	(2)	Establish metrics and benchmarks for the department of
19		transportation to ensure progress on state goals
20		related to ground transportation, safety, and
21		modernization and other related goals;



1	(3)	Review projects in development and make
2		recommendations for how each might be improved, if
3		warranted, to better meet state goals, before project
4		plans and designs are finalized;
5	(4)	Provide direction to the department and make
6		recommendations to the legislature as necessary to
7		ensure progress on state goals related to ground
8		transportation, safety, modernization, and other
9		related goals;
10	(5)	Advise the governor, legislature, and public on
11		matters relating to the programs [and], activities,
12		projects, outcomes, and recommendations of the State
13		in the field of [highway] transportation safety[-] and
14		modernization; and
15	(6)	Submit an annual report to the department of
16		transportation that reflects the work,
17		responsibilities, and recommendations of the council.
18	(c)	The department of transportation shall:
19	(1)	Provide regular updates on ground transportation
20		plans, projects, progress, and any other relevant
