### A BILL FOR AN ACT

RELATING TO VOTER REGISTRATION.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

SECTION 1. The legislature finds that voter turnout in the State remains low and continues to decline. In 2022, Hawaii had one of the lowest voter turnouts in the United States. Only 4 88.7 per cent of registered Hawaii voters cast ballots in the 2022 general election. This represents a sharp decline in voter turnout over the years, as approximately ninety-four per cent of registered voters cast ballots in the State's first

8 gubernatorial election in 1959.

9 Additionally, the State has a historically low rate of
10 registered voters. According to a 2016 estimate from the United
11 States Census Bureau, Hawaii had the lowest percentage of
12 registered voters in the country at 49.8 per cent, well below
13 the national average of 64.2 per cent. Therefore, of the
14 1,064,000 people in Hawaii who were qualified to vote in the
15 2016 election, 534,128 were not registered to vote.

16 The legislature further finds that voting at a young age
17 creates and empowers life-long voters. Data shows that after an

individual votes once, the individual often becomes a habitual
 voter. Therefore, by facilitating the ability of those sixteen
 years of age and older to preregister or register to vote, the
 State can empower a new generation of lifelong voters.

5 Accordingly, the purpose of this Act is to increase voter 6 participation and encourage civic engagement in Hawaii's public 7 higher education institutions by establishing a process for the 8 automatic preregistration and registration of University of 9 Hawaii system-enrolled students who are at least sixteen years 10 of age.

SECTION 2. Chapter 11, Hawaii Revised Statutes, is amended by adding a new section to part II to be appropriately designated and to read as follows:

14 "§11- Automatic voter preregistration and registration;
15 opt out. (a) Beginning January 1, 2024, any person who:
16 (1) Is enrolled in the University of Hawaii system at any

- 18 (2) Is otherwise qualified to preregister or register to
  19 vote under this part;
- 20 (3) Is at least sixteen years of age; and

1	(4) Properly completes and submits a voter registration
2	affidavit,
3	shall be automatically preregistered or registered to vote as
4	provided in this section.
5	(b) Between January 1 and January 31 of each year, the
6	chancellor of each University of Hawaii campus shall provide and
7	may collect from each student who is at least sixteen years of
8	age a voter affidavit containing the information required by
9	section 11-15 to allow the student to preregister or register to
10	vote or to opt out of preregistering or registering to vote.
11	The chancellor of each University of Hawaii campus shall
12	transmit the collected voter registration affidavits to the
13	clerk of the county in which the applicant resides; provided
14	that the chancellor of each University of Hawaii campus shall
15	not maintain, scan, review, or copy any voter affidavit nor
16	transmit any information maintained by the University of Hawaii.
17	(c) Upon receipt of a collected voter registration
18	affidavit, the clerk shall determine whether the applicant is
19	currently preregistered or registered in the general county
20	register."

1	SECTION 3. Chapter 304A, Hawaii Revised Statutes, is
2	amended by adding a new section to part II, subpart G, to be
3	appropriately designated and to read as follows:
4	" <u>§304A-</u> Automatic voter preregistration and
5	registration. The board of regents and the chancellor of each
6	campus, in consultation with the office of elections, may adopt
7	policies as necessary to maximize and facilitate the
8	preregistration and registration of qualifying students to vote
9	as provided in section 11"
10	SECTION 4. New statutory material is underscored.
11	SECTION 5. This Act shall take effect on January 1, 2024.
