18 Currently, corrections and certain law enforcement 19 functions and activities are placed within the department of 20 public safety. The legislature finds that the goals and 21 functions of corrections and law enforcement are different and 22 distinct and separating the functions of corrections and law

enforcement from the department of public safety into two
 departments would best accomplish the discrete goals and
 objectives of both functions.

4 The legislature further finds that state criminal law 5 enforcement personnel and functions are currently spread across 6 various departments. The department of public safety, 7 department of transportation, and department of the attorney 8 general all have independent law enforcement officers and 9 different law enforcement duties. Because each department 10 administers its own law enforcement duties, goals, and 11 functions, training and operational standards differ between 12 each department. Accordingly, the reorganization of certain 13 state law enforcement functions into a single entity would 14 provide the highest level of law enforcement service for the 15 public, state employees, and state properties. Consolidation of 16 certain state criminal law enforcement responsibilities into a 17 single state department will centralize state law enforcement 18 functions to increase public safety, improve decision making, 19 promote accountability, streamline communication, decrease 20 costs, reduce duplication of efforts, and provide uniform 21 training and standards.

1 The goals of the department of law enforcement would 2 include: 3 (1) Establishing a partnership with the federal Joint 4 Terrorism Task Force to protect the State from domestic and foreign threats; 5 Eliminating the narcotics epidemic that plagues 6 (2) Hawaii's communities through its commitment of 7 8 investigators in the federal High Intensity Drug Trafficking Area task forces; 9 Expanding the narcotics canine program; and 10 (3) Reducing gun violence and other violent criminal acts 11 (4)12 in island communities through participation in the 13 federal Project Safe Neighborhoods program. 14 This Act also establishes a training center within the 15 department of law enforcement to provide its law enforcement 16 entities the highest level of core and continuing education and 17 training. The training center will also be made available to 18 federal, state, and county law enforcement agencies upon their 19 request. The development of a department of law enforcement 20 training center, where all department of law enforcement 21 officers who intend to work on any island of Hawaii must be 22 certified, will ensure that all department of law enforcement

officers meet the standards set by the law enforcement standards 1 board established in chapter 139, Hawaii Revised Statutes. 2 The center will also ensure that the individuals who earn its 3 certification have learned the highest level of core and 4 5 continuing education and training. The center's curriculum will 6 be designed to ensure that the individuals trained here have the 7 knowledge and skills to protect and serve the public and will be 8 held accountable if they do not uphold the standards set by the law enforcement standards board. 9

The legislature also finds that consolidating adult 10 11 corrections, reentry services, and other related functions into a separate department of corrections and rehabilitation will 12 allow for the efficient use of resources in administering 13 correctional programs and administering and maintaining public 14 15 and private correctional services. The Hawaii correctional 16 industries, Hawaii paroling authority, and crime victim compensation commission will be administered by the department 17 of corrections and rehabilitation. 18

19 The legislature intends that patrol officers assigned to 20 the department of law enforcement continue to retain the title 21 of deputy sheriffs. During the Kingdom of Hawaii, sheriffs 22 oversaw law enforcement activities on each island under the

supervision of a kingdom-wide marshal. From 1905 to 1960,
 sheriffs protected the public as elected county officials,
 including Duke Kahanamoku, who was elected Honolulu sheriff from
 1934 to 1960. Modern-day deputy sheriffs have protected the
 people of Hawaii for nearly fifty years, beginning in 1963 when
 the legislature created the office of the sheriff within the
 department of the attorney general.

8 The legislature does not intend to impair or diminish the 9 longstanding authority and responsibility of county police departments to enforce the laws, along with state law 10 11 enforcement, on state lands within their respective 12 counties. County police departments will continue to have full 13 law enforcement authority and responsibility, and in particular will continue to have concurrent jurisdiction with respect to 14 15 state parks, state buildings, state highways, Hawaiian home lands, and other state lands and facilities. 16

17 Part II of this Act is to be effective upon approval of 18 this Act. Part II establishes a department of law enforcement 19 and its director and deputy directors. The department of law 20 enforcement will initially be staffed by its director, deputy 21 directors, and certain administrative staff. These personnel

will prepare for the transfer of state law enforcement functions
 and personnel to the department on January 1, 2024.

3 Part III of this Act is to be effective on January 1,
4 2024. Part III transfers the law enforcement functions and
5 personnel from the department of public safety to the department
6 of law enforcement and makes conforming amendments.

Part IV of this Act is to be effective on January 1, 7 8 2024. Part IV renames the department of public safety as the 9 department of corrections and rehabilitation and the director of 10 public safety as the director of corrections and rehabilitation, 11 establishes its deputy directors, and makes conforming 12 amendments so that the authority and responsibilities of the 13 department of corrections and rehabilitation are set forth in 14 chapter 353, Hawaii Revised Statutes, while the authority and 15 responsibilities of the department of law enforcement are set 16 forth in chapter 353C, Hawaii Revised Statutes.

17 Part V of this Act is to be effective on January 1, 18 2024. Part V transfers the law enforcement and security 19 functions and personnel of the harbors division of the 20 department of transportation, [the non-statutorily mandated 21 functions and] certain law enforcement personnel of the 22 investigations division of the department of the attorney

general, and the office of homeland security of the department
 of defense to the department of law enforcement.

3 Part VI of this Act provides for the retention of civil
4 service status and related rights of transferred employees and
5 transfers any appropriations, equipment, contracts, leases,
6 policies, rules, guidelines, and other items to the respective
7 departments as provided in this Act.

8 Part VII of this Act is to be effective on July 1, 2022. Part VII establishes new positions within the department 9 of law enforcement that are required for the department's 10 11 operations. These positions include the director of law enforcement, deputy directors, and certain administrative 12 positions that will staff the department, as well as new 13 positions that will be required when parts III and V take effect 14 15 on January 1, 2024. Part VII also appropriates funds to the 16 department of law enforcement to fill certain positions that 17 will be required to prepare the department for the transfer of 18 functions, personnel, and assets from other departments on January 1, 2024. Part VII further requires the department of 19 20 law enforcement to report to the legislature, no later than 21 twenty days prior to the convening of the regular session of

1 2023, the progress made in preparing for the transfer of law 2 enforcement functions to the department on January 1, 2024. Part VIII of this Act is to be effective on January 1, 3 4 2024. Part VIII establishes new positions within the department of corrections and rehabilitation that will be required for the 5 6 operation of the department when parts III and IV take effect on 7 January 1, 2024." SECTION 3. Act 278, Session Laws of Hawaii 2022, is 8 amended by amending section 7 to read as follows: 9 "SECTION 7. Chapter 353C, Hawaii Revised Statutes, is 10 11 amended by adding a new section to be appropriately designated and to read as follows: 12 Statewide law enforcement training center; law 13 "§353Cenforcement complex. There is established within the department 14 15 a department of law enforcement training center. The center shall provide training and administer certification requirements 16 of all state department of law enforcement personnel who 17 18 exercise police powers in the State, and be available for all 19 county law enforcement agencies [-,] and other state law 20 enforcement personnel who exercise police powers in the State. DEPARTMENT: Law Enforcement

TITLE: A BILL FOR AN ACT RELATING TO ACT 278, SESSION LAWS OF HAWAII 2022.

- PURPOSE: To amend Act 278, Session Laws of Hawaii 2022, to modify the transfer of the personnel and functions of the Department of the Attorney General to the Department of Law Enforcement; clarify that Act 278 does not amend or abrogate the Attorney General's status as the chief legal and law enforcement officer of the State; specify that the Statewide Law enforcement Training Complex will be located at the First Responder Technology Campus rather than the Mililani Technology Park; and transfer the responsibility and management of certain private security contracts under section 26-14.6, Hawaii Revised Statutes, from the Department of Law Enforcement to the Department of Defense (DOD), the Department of Health (DOH), and the Department of Human Services (DHS) for their respective facilities.
- MEANS: Amend section 26-14.8, Hawaii Revised Statutes, sections 1, 7, 11, 21, 34, 48, 49, 55 of Act 278, Session Laws of Hawaii 2022.
- JUSTIFICATION: The proposed amendment modifies the transfer of the personnel and functions of the Department of the Attorney General to the Department of Law Enforcement while clarifying that Act 278 does not amend or abrogate the Attorney General's status as the Chief Legal and Law Enforcement Officer of the State.

Act 278 incorrectly identified the Mililani Technology Park as the location of the Statewide Law Enforcement Training Center and Law Enforcement Complex when it should

have been the First Responder Technology Campus.

Additionally, transferring the management of private security contracts from the Department of Law Enforcement to DOD, DOH, and DHS for their respective facilities will increase efficiencies by ensuring the departments retain greater control of these contracts, based on their direct access to on-the-ground information.

Impact on the public: There will be little or no impact to the public.

Impact on the department and other agencies: The proposed measure will eliminate the Department of Law Enforcement's involvement in managing private security contracts for the facilities of the DOD, DOH, and DHS and increase the efficiencies and control for these departments.
