### JUSTIFICATION SHEET SB. NO. 1338

DEPARTMENT: Law Enforcement

TITLE: A BILL FOR AN ACT RELATING TO THE ENHANCED 911 BOARD.

PURPOSE: To add the director of the Department of Law Enforcement or the director's designee as a member of the Enhanced 911 Board.

MEANS: Amend section 138-2(a), Hawaii Revised Statutes (HRS).

JUSTIFICATION: The proposed amendments to section 138-2(a) are intended to allow the Director of Law Enforcement, or the director's designee, to participate as a member on the Enhanced 911 Board. This is critical as the new Department of Law Enforcement intends to strengthen its role in emergency response and improving public safety.

> Impact on the public: This bill will protect the public by allowing the Department of Law Enforcement to build critical relationships and participate in critical discussions that will assist in modernizing the department's emergency communications and response.

> Impact on the department and other agencies: This bill will assist the Department of Law Enforcement in modernizing its emergency communications and response, thereby allowing the department to better interoperate with other first responder agencies.
