BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 244D-1, Hawaii Revised Statutes, is 2 amended by amending the definition of "beer" to read as follows: 3 ""Beer" means any alcoholic beverage containing no less 4 than 0.5 per cent alcohol by volume obtained by the fermentation 5 or any infusion or decoction of [barley,] malt, [hops, or any 6 other similar product, or any combination thereof in water, and] 7 wholly or in part, or any substitute therefor, including grain of any kind, bran, glucose, sugar, or molasses. "Beer" includes 8 9 ale, porter, brown, stout, lager beer, small beer, [and] strong 10 beer [but], and alcoholic seltzer beverages. "Beer" does not 11 include sake, known as Japanese rice wine, [or] cooler 12 beverage [-,], or a product of distillation, by whatever name 13 known, that contains distilled spirits, alcoholic spirits, or 14 spirits." 15 SECTION 2. Section 281-1, Hawaii Revised Statutes, is
