A BILL FOR AN ACT

RELATING TO VESSELS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that as working harbors, 2 many of Hawai'i's harbors produce large amounts of noise. While 3 the department of transportation has the authority to adopt 4 rules regulating the manner in which vessels may enter and moor, 5 anchor, or dock in the commercial harbors, ports, and roadsteads, this authority does not allow the department of 6 7 transportation to adopt rules to regulate excessive and harmful noises emanating from these vessels. The legislature further 8 finds that granting the department of transportation this 9 10 authority will help alleviate the concerns of individuals 11 affected by the noise from Hawai'i's harbors.

SECTION 2. Section 266-3, Hawaii Revised Statutes, is
amended by amending subsection (a) to read as follows:

14 "(a) The director of transportation may adopt rules as 15 necessary:

16 (1) To regulate the manner in which all vessels may enter17 and moor, anchor, or dock in the commercial harbors,

freight, goods, wares, and merchandise in and upon the docks, wharves, piers, quays, bulkheads, or landings within the commercial harbors, ports, and roadsteads of the State." SECTION 3. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. SECTION 4. This Act shall take effect on July 1, 2050.
