#### A BILL FOR AN ACT

RELATING TO HAWAIIAN HOME LANDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Hawaiian Homes Commission Act, 1920, as
2	amended,	is amended by adding five new sections to be
3	appropria	tely designated and to read as follows:
4	" <u>§</u> A.	Qualifications of commission members. (a) No person
5	shall be	eligible for election to the commission unless the
6	person:	
7	(1)	Is a beneficiary under this Act;
8	(2)	Will be a resident of the State for at least three
9		years by the date of the person's election to the
10		commission;
11	(3)	Has attained the age of eighteen years or will have
12		attained that age within one year of the date of the
13		next election of commission members; and
14	(4)	Is otherwise qualified to register to vote in the
15		State.
16	(b)	No member of the commission shall hold or be a
17	candidate	for any other public office under the state or county



1	governmen	ts in accordance with article II, section 7, of the
2	<u>Constitut</u> :	ion of the State of Hawaii; nor shall a person be
3	eligible	for election to the commission if that person is also a
4	candidate	for any other public office under the state or county
5	governmen	ts. For the purposes of this subsection, the term
6	<u>"public o</u>	ffice" shall not include notaries public, reserve
7	police of	ficers, or officers of emergency organizations for
8	<u>civilian</u>	defense or disaster, or disaster relief.
9	<u>§B.</u>	Qualifications of the director of Hawaiian home lands.
10	(a) No po	erson shall be eligible for election to office of
11	director	of Hawaiian home lands unless the person:
12	(1)	Meets all qualifications for the office as established
13		by state law;
14	(2)	Will be a resident of the State for at least three
15		years by the date of the person's election to the
16		commission; and
17	(3)	Is otherwise qualified to register to vote in the
18		State.
19	(b)	No director of Hawaiian home lands shall hold or be a
20	candidate	for any other public office under the state or county
21	governmen	ts in accordance with article II, section 7, of the



1	Constitution of the State of Hawaii; nor shall a person be
2	eligible for election to the office of director of Hawaiian home
3	lands if that person is also a candidate for any other public
4	office under the state or county governments. For the purposes
5	of this subsection, the term "public office" shall not include
6	notaries public, reserve police officers, or officers of
7	emergency organizations for civilian defense or disaster, or
8	disaster relief.
9	SC. Election of commission members; director. (a)
10	Members of the commission and the director of Hawaiian home
11	lands shall be elected at a special election held in conjunction
12	with the general election in every even-numbered year.
13	(b) Any person intending to register as a candidate for
14	the election as a commission member or director of Hawaiian home
15	lands shall submit to an examination under oath by the clerk of
16	the county in which the person resides relating to the person's
17	qualifications. In addition, each candidate shall make and
18	subscribe to an application in the form of an affidavit
19	verifying the candidate's qualifications.
20	(c) The chief election officer shall prepare the
21	nomination papers in a manner that enables a candidate desiring



1	to file for election to the commission to specify that the
2	candidate is seeking a seat requiring residency in a particular
3	location.
4	(d) The ballot for the election of commission members
5	shall be prepared in a manner that provides to each voter
6	qualified and registered under this Act the opportunity to cast
7	ballots for the commission candidate or candidates seeking
8	election to the commission seat or seats representing the county
9	in which the voter resides. Each ballot shall contain the names
10	of the candidates arranged alphabetically. Each eligible voter
11	shall be entitled to:
12	(1) Receive the commission ballot and to vote for the
13	number of seats available in the county in which the
14	voter resides; and
15	(2) Receive the director of Hawaiian home lands ballot and
16	vote for one candidate for that office.
17	(e) The cost of the election of commission members and
18	director of Hawaiian home lands shall be borne by the department
19	of Hawaiian home lands using the Hawaiian home lands trust fund.
20	<b>SD. Qualification of voters; registration.</b> No person
21	shall be eligible to register as a voter for the election of



1	commission members or the director of Hawaiian home lands unless
2	the person is qualified to register to vote in the State under
3	applicable law.
4	SE. Commissioners; directors; terms of office; vacancies.
5	(a) The term of office of members of the commission and
6	director of Hawaiian home lands shall be two years, beginning on
7	the day of the special election held in conjunction with the
8	general election of the year in which they are elected and
9	ending on the day of the special election held in conjunction
10	with the following general election.
11	(b) No person may serve as a member of the commission for
12	more than two terms, or four total years in the case of
13	nonconsecutive terms.
14	(c) No person may be serve as the director of Hawaiian
15	home lands for more than terms.
16	(d) Any vacancy that may occur through any cause other
17	than the expiration of the term of office shall be filled in
18	accordance with applicable state law."
19	SECTION 2. Section 202, Hawaiian Homes Commission Act,
20	1920, as amended, is amended to read as follows:

1	"§202. Department officers, staff, commission, members,
2	compensation. (a) There shall be a department of Hawaiian home
3	lands which shall be headed by an executive board to be known as
4	the Hawaiian homes commission. The members of the commission
5	shall be [nominated and appointed in accordance with section
6	26 34, Hawaii Revised Statutes.] elected in accordance with this
7	Act and applicable state law. The commission shall be composed
8	of nine members[ $ au$ ] elected pursuant to section C of this Act, as
9	follows: [three shall be residents of the city and county of
10	Honolulu; two shall be residents of the county of Hawaii one of
11	whom shall be a resident of east Hawaii and the other a resident
12	of west Hawaii; two shall be residents of the county of Maui one
13	of whom shall be a resident from the island of Molokai; one
14	shall be a resident of the county of Kauai; and the ninth member
15	shall-be-the-chairman-of-the-Hawaiian-homes-commission. All
16	members shall have been residents of the State at least three
17	years prior to their appointment and at least four of the
18	members shall be descendants of not less than one fourth part of
19	the blood of the races inhabiting the Hawaiian Islands previous

2	full time capacity. He shall, in such capacity, perform such

5	provided above.] chairperson of the commission shall be
6	responsible for conducting the meetings of the commission.
7	There shall be a director of Hawaiian home lands elected in
8	accordance with this Act and applicable state law. The duties
9	of the director shall be determined by state law. The director
10	shall serve without pay, but shall be compensated for actual
11	expenses incurred in the discharge of official duties.
12	(b) The provisions of section 76-16, Hawaii Revised
13	Statutes, shall apply to the positions of first deputy and
14	private secretary to the [ <del>chairman of the commission.</del> ] <u>director</u>
15	of Hawaiian Home lands. The department may hire temporary staff
16	on a contractual basis not subject to chapters 76 and 78, Hawaii
17	Revised Statutes, when the services to be performed will assist
18	in carrying out the purposes of the Act. These positions may be
19	funded through appropriations for capital improvement program
20	projects and by the administration account, operating fund, or
21	native Hawaiian rehabilitation fund. No contract shall be for a



2 contract may be employed for a maximum of six years; provided 3 that the six-year limitation shall not apply if the department, 4 with the approval of the governor, determines that [such] 5 contract individuals are needed to provide critical services for 6 the efficient functioning of the department. All other 7 positions in the department shall be subject to chapter 76, 8 Hawaii Revised Statutes. 9 All vacant and new civil service positions covered by 10 chapter 76, Hawaii Revised Statutes, shall be filled in accordance with section 76-22.5, Hawaii Revised Statutes; 11 12 provided that the provisions of these sections shall be applicable first to qualified persons of Hawaiian extraction." 13 14 SECTION 3. Chapter 17, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to 15 16 read as follows: 17 "§17-Hawaiian homes commission; director of Hawaiian 18 home lands; vacancies. Whenever any vacancy in the membership 19 of the Hawaiian homes commission or the office of director of 20 Hawaiian home lands occurs, the vacancy shall be filled for the 21 unexpired term at the next succeeding special election held in

4	shall file nomination papers not later than 4:30 p.m. on the

7	the first working day immediately preceding) and shall be
8	elected in accordance with the Hawaiian Homes Commission Act of

11	island on which the appointed person's predecessor resided
12	immediately before the vacancy occurred. The person appointed
13	shall serve for the duration of the unexpired term, and shall

16	SECTION 4. Section 12-5, Hawaii Revised Statutes, is
17	amended by amending subsection (c) to read as follows:
18	"(c) Nomination papers for candidates for members of the
19	board of trustees of the office of Hawaiian affairs, members of
20	the Hawaiian homes commission, and director of Hawaiian home

1 <u>lands</u> shall be signed by not less than twenty-five persons
2 registered to vote."

SECTION 5. Section 12-6, Hawaii Revised Statutes, is 3 4 amended by amending subsection (a) to read as follows: 5 "(a) For members of Congress, state offices, county 6 offices, the Hawaiian homes commission, the director of Hawaiian 7 home lands, and the board of trustees for the office of Hawaiian 8 affairs, nomination papers shall be filed with the chief 9 election officer, or clerk in case of county offices, not later 10 than 4:30 p.m. on the first Tuesday in June. However, in the 11 event of a special primary or special election, the filing 12 deadline shall be determined in the proclamation that is issued calling for the election as provided for by state law or county 13 14 charter. A state candidate from the counties of Hawaii, Maui, 15 and Kauai may file the declaration of candidacy with the 16 respective clerk. The clerk shall transmit to the office of the 17 chief election officer the state candidate's declaration of 18 candidacy without delay."

19 SECTION 6. Section 26-17, Hawaii Revised Statutes, is20 amended to read as follows:

1 "§26-17 Department of Hawaiian home lands. (a) The 2 department of Hawaiian home lands shall be headed by an 3 executive board to be known as the Hawaiian homes commission. 4 The commission shall be composed of nine members. The [appointment,] election, tenure, and removal of the members and 5 6 the filling of vacancies on the commission shall be in 7 accordance with section [26-34] 17- and section [202(a)] C of 8 the Hawaiian Homes Commission Act of 1920, as amended. The 9 [governor] members shall appoint the chairperson of the 10 commission from among [the] its members [thereof]. 11 The [commission may delegate to the chairperson such 12 duties, powers, and authority, or so much thereof as may be 13 lawful or proper, for the performance of the functions vested in 14 the commission. 15 The chairperson of the board shall serve in a full time capacity and shall perform such duties, and exercise such powers 16 17 and authority, or so much thereof as may be delegated to the 18 chairperson by the board.] chairperson of the commission shall 19 be responsible for conducting the meetings of the commission. 20 (b) There shall be a director of Hawaiian home lands. The 21 director shall have oversight over the administration of the



1 department, and shall perform other duties as required by the 2 commission and applicable law. 3 The election and tenure of the director and the filling of 4 a vacancy in the office of director of Hawaiian home lands shall 5 be in accordance with section 17- and section C of the 6 Hawaiian Homes Commission Act of 1920, as amended. 7 (c) The department shall administer the Hawaiian Homes Commission Act of 1920 as set forth in the Constitution of the 8 9 State and by law. 10 The functions and authority heretofore exercised by the 11 Hawaiian homes commission as heretofore constituted are 12 transferred to the department of Hawaiian home lands established by this chapter." 13 14 SECTION 7. Section 26-34, Hawaii Revised Statutes, is 15 amended by amending subsection (a) to read as follows: 16 The members of each board and commission established "(a) 17 by law, except the Hawaiian homes commission, shall be nominated 18 and, by and with the advice and consent of the senate, appointed 19 by the governor. Unless otherwise provided by this chapter or 20 by law hereafter enacted, the terms of the members shall be for 21 four years; provided that the governor may reduce the terms of

1 those initially appointed so as to provide, as nearly as can be, 2 for the expiration of an equal number of terms at intervals of 3 one year for each board and commission. Unless otherwise 4 provided by law, each term shall commence on July 1 and expire 5 on June 30, except that the terms of the chairpersons of the 6 board of agriculture, the board of land and natural resources, 7 and the Hawaiian homes commission shall commence on January 1 and expire on December 31. No person shall be appointed 8 9 consecutively to more than two terms as a member of the same 10 board or commission; provided that membership on any board or 11 commission shall not exceed eight consecutive years."

SECTION 8. The terms of the appointed members of the Hawaiian homes commission, including the chairperson, shall expire on the day of the first special election to elect members of the commission that occurs after congressional approval of this Act.

SECTION 9. If any provision of this Act, or the application thereof to any person or circumstance, is held invalid, the invalidity does not affect other provisions or applications of the Act that can be given effect without the

1 invalid provision or application, and to this end the provisions 2 of this Act are severable.

3 SECTION 10. In codifying the new sections added by 4 section 1 and referenced in sections 3 and 6 of this Act, the 5 revisor of statutes shall substitute appropriate section numbers 6 for the letters used in designating the new sections in this 7 Act.

8 SECTION 11. Statutory material to be repealed is bracketed 9 and stricken. New statutory material is underscored.

10 SECTION 12. This Act shall take effect upon its approval 11 by the governor of the State of Hawaii with the consent of the 12 United States Congress.
