RELATING TO THE WORKS OF ART SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 103-8.5, Hawaii Revised Statutes, is amended as follows:

3 1. By amending subsection (a) to read:

"(a) There is created a works of art special fund, into 4 5 which shall be transferred one-half of one per cent of all state 6 fund appropriations for capital improvements designated for the 7 construction cost element; provided that this transfer shall 8 apply only to capital improvement appropriations that are 9 designated for the construction or renovation of state 10 buildings. The one-half of one per cent transfer requirement 11 shall not apply to appropriations from the passenger facility 12 charge special fund established by section 261-5.5 and the 13 rental motor vehicle customer facility charge special fund 14 established under section 261-5.6."

15 2. By amending subsection (c) to read:

16 "(c) The <u>one-half of</u> one per cent amount, which is
17 included in all capital improvement appropriations, shall be

1 calculated at the time the appropriation bills are signed into law. The moneys shall be transferred into the works of art 2 special fund upon availability of moneys from the 3 appropriations. Each agency receiving capital improvement 4 5 appropriations shall calculate the one-half of one per cent amount and transfer the moneys into the works of art special 6 fund." 7 3. By amending subsections (e) and (f) to read: 8 9 "(e) The comptroller shall: Provide each agency receiving capital improvement 10 (1) 11 appropriations with information regarding items that 12 shall be included and excluded from the one-half of 13 one per cent amount; 14 (2) Ensure that each agency calculates its one-half of one 15 per cent amount correctly; and 16 (3) Ensure that each agency transfers the correct amount to the works of art special fund in a timely manner. 17 The comptroller and the executive director shall track 18 (f) 19 amounts due from each agency under the one-half of one per cent 20 requirement as provided in this section."
