# A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
TWENTIETH SENATORIAL DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The twentieth senatorial district encompasses  
2 Ewa Beach, Ocean Pointe, Ewa By Gentry, Iroquois Point, and a  
3 portion of Ewa Villages.

4           Accordingly, the purpose of this Act is to appropriate  
5 funds for capital improvement projects in the twentieth  
6 senatorial district.

7           SECTION 2. The director of finance is authorized to issue  
8 general obligation bonds in the sum of \$105,920,000 or so much  
9 thereof as may be necessary and the same sum or so much thereof  
10 as may be necessary is appropriated for fiscal year 2024-2025  
11 for the purpose of financing capital improvement projects for  
12 the twentieth senatorial district, as follows:

13       1. To be expended by the department of transportation:

1 SECTION 3. The appropriation made for the capital  
2 improvement projects authorized by this Act shall not lapse at  
3 the end of the fiscal biennium for which the appropriation is  
4 made; provided that all moneys from the appropriation  
5 unencumbered as of June 30, 2027, shall lapse as of that date.

6 SECTION 4. The sums appropriated for the respective  
7 capital projects set forth in section 2 shall be expended by the  
8 designated expending agency for the purposes of this Act.

9 SECTION 5. This Act shall take effect on July 1, 2024.
