BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 103D-307, Hawaii Revised Statutes, is

Without the needed good, service, or construction, the (3) 6 7 continued functioning of government, the preservation 8 or protection of irreplaceable property, or the health and safety of any person will be seriously threatened. 9 10 The emergency procurement shall be made with such (b) competition as is practicable under the circumstances [and, 11 12 where practicable, approval from the chief procurement officer 13 shall be obtained prior to the procurement]. A written determination of the basis for the emergency and for the 14 selection of the particular contractor shall be included in the 15 16 contract file.

Description:

Amends section 103D-307, HRS, to add equipment failures, repairs of public property to protect against further loss of, or damage to, public property, to prevent or minimize serious disruption in continued functioning of government services. Replaces Chief Procurement Officer approval with an accounting report to the legislature within sixty days after the end of the fiscal year in which the procurement was made.

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO PROCUREMENT.

PURPOSE: To amend section 103D-307, Hawaii Revised Statutes, "Emergency procurements," to add equipment failures, repairs to public property to protect against further loss of, or damage to public property, to prevent or minimize serious disruption in continued functioning of government services; and to replace chief procurement officer approval with an accounting report to the Legislature within sixty days after the end of the fiscal year in which the procurement was made.

MEANS: Amend section 103D-307, Hawaii Revised Statutes.

JUSTIFICATION: Maintenance schedules to extend the useful life of a facility or equipment is the primary function of preventive maintenance. A procuring agency's practical response to budgetary limitations may result in deferred maintenance or, when appropriate, through an emergency procurement.

> <u>Impact on the public:</u> This bill broadens allowable emergency procurements within the intent of the Procurement Code's competition requirements. It shifts the showing of transparency from requiring approval from the chief procurement officer to a reporting by the head of the purchasing agency to the Legislature.

> Impact on the department and other agencies: This bill will allow the head of the purchasing agency to determine when it is appropriate to conduct an emergency procurement.
