A BILL FOR AN ACT

RELATING TO SAFE NEIGHBORHOODS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 706, Hawaii Revised Statutes, is
2	amended by adding a new section to part II to be appropriately
3	designated and to read as follows:
4	"§706- Probationary geographic restrictions; Ewa Beach;
5	Kapolei; Waianae. (1) A defendant who has been convicted of a
6	misdemeanor, has two prior misdemeanor convictions, and each
7	conviction was the result of an act that occurred within a
8	covered district may be sentenced to a probationary term of
9	geographic restriction not exceeding years, during which
10	the defendant shall be prohibited from entering the covered
11	district in which the acts occurred between the hours of
12	6:00 p.m. to 6:00 a.m.
13	(2) Violation of an imposed geographic restriction shall
14	be a misdemeanor and shall result in imprisonment of thirty
15	days.
16	(3) For purposes of this section:
17	"Covered district" means any one of the following areas:

- 1 (a) Ewa Beach;
- 2 (b) Kapolei; or
- 3 (c) Waianae.
- 4 "Ewa Beach" means the area of Oahu that is designated as

5 postal code 96706 by the United States Postal Service as of the

- 6 effective date of this section.
- 7 "Kapolei" means the area of Oahu that is designated as

8 postal code 96707 by the United States Postal Service as of the

- 9 effective date of this section.
- 10 "Waianae" means the area of Oahu that is designated as

11 postal code 96792 by the United States Postal Service as of the

12 effective date of this section."

13 SECTION 2. This Act does not affect rights and duties that 14 matured, penalties that were incurred, and proceedings that were 15 begun before its effective date.

Report Title:

Probation; Geographic Restriction; Misdemeanor Conviction; Ewa Beach; Kapolei; Waianae

Description:

Allows a defendant who has been convicted of three misdemeanors in the Ewa Beach area, Kapolei area, or Waianae area to be sentenced to a probationary term of geographic restriction during which the defendant shall be prohibited during certain hours from entering the specific area in which the acts occurred. Mandates imprisonment of 30 days for a violation of the geographic restriction.
