RELATING TO EMPLOYMENT PRACTICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 378, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Paid rest periods; paid meal periods. "§378-(a) 5 Employees shall be allowed: 6 (1) A paid rest period of at least fifteen consecutive 7 minutes for each four hours of working time; and (2) 8 A paid meal period of at least thirty consecutive 9 minutes for each eight hours of working time." 10 SECTION 2. Section 390-2, Hawaii Revised Statutes, is 11 amended by amending subsection (c) to read as follows: 12 "(c) A minor who has attained the age of fourteen years 13 but not sixteen years may be employed or permitted to work: 14 (1) During periods when the minor is not legally required 15 to attend school or when the minor is excused by 16 school authorities from attending school;
