SENATE CONCURRENT RESOLUTION

AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT HAUULA, KOOLAULOA, OAHU, FOR THE EXISTING RIPRAP REVETMENT, RAMP, AND ROCK GROIN, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON.

1 WHEREAS, portions of the existing riprap revetment, ramp, and rock groin seaward of the property identified as Tax Map 2 Key: (1) 5-3-008:012, Hauula, Koolauloa, Oahu (subject 3 4 property), were placed on state submerged lands; and 5 6 WHEREAS, the riprap revetment and rock groin were first 7 placed along several adjacent properties, known as the Kaluanui 8 Beach Lots, in 1947; and 9 10 WHEREAS, in October 1961, the riprap revetment wall and rock groins were repaired and improved by a contractor engaged 11 by Bishop Estate, the then-owner of the Kaluanui Beach Lots; and 12 13 14 WHEREAS, in 1983 and 1984, during the process of shoreline certification, it was discovered that the riprap revetment, 15 ramp, and rock groin were encroachments on state submerged land 16 and there was an attempt to resolve the encroachments with the 17 then-owner of the abutting residential parcel, however, there is 18 19 no record of any issuance of a land disposition or removal of 20 the encroachments; and 21 22 WHEREAS, in 2017, Steven Ernest MacBride and Valerie Jean MacBride purchased the residential subject property, which abuts 23 the portion of state submerged land that contains the 24 encroaching riprap revetment, ramp, and rock groin; and 25 26 27 WHEREAS, around November 2018, title to the residential subject property, which abuts the encroaching riprap revetment, 28 ramp, and rock groin was conveyed to Steven Ernest MacBride and 29 Valerie Jean MacBride, as Trustees under that certain unrecorded 30

Steven and Valerie MacBride Revocable Trust dated October 30, 1 2 2018; and 3 WHEREAS, the riprap revetment, ramp, and rock groin was 4 constructed seaward of the private property record boundary 5 without prior authorization, and a portion of the riprap 6 7 revetment, ramp, and rock groin previously located on private property but is now seaward of the current shoreline on state 8 9 submerged lands; and 10 WHEREAS, around April 2022, the Department of Land and 11 12 Natural Resources' Office of Conservation and Coastal Lands worked with Steven Ernest MacBride and Valerie Jean MacBride, as 13 14 Trustees under that certain unrecorded Steven and Valerie MacBride Revocable Trust dated October 30, 2018, to resolve the 15 16 encroachments; and 17 WHEREAS, the Office of Conservation and Coastal Lands 18 indicated that it supported a non-exclusive easement to resolve 19 20 the encroachments; and 21 WHEREAS, at its meeting of August 26, 2022, under agenda 22 item D-5, the Board of Land and Natural Resources approved a 23 grant of a 25-year non-exclusive easement to resolve the riprap 24 revetment, ramp, and rock groin encroachments, and such non-25 exclusive easement shall run with the land and shall inure to 26 the benefit of the abutting real property; and 27 28 WHEREAS, the total encroachment area was determined to be 29 2,297 square feet, more or less, as reviewed and approved by the 30 Department of Accounting and General Services' Survey Division; 31 32 and 33 WHEREAS, on October 14, 2022, Steven Ernest MacBride and 34 Valerie Jean MacBride, as Trustees under that certain unrecorded 35 Steven and Valerie MacBride Revocable Trust dated October 30, 36 2018, executed a removal bond in the amount of \$79,860 with 37 SureTec Insurance Company as surety and the State of Hawaii as 38 oblige, to insure the State against the cost of removing the 39 encroachments in the event that the Legislature and the Governor 40 41 do not approve the issuance of the easement approved by the Board of Land and Natural Resources; and 42 43

1 WHEREAS, the Board of Land and Natural Resources executed 2 Revocable Permit No. S-7945 on January 17, 2023, granting Steven 3 Ernest MacBride and Valerie Jean MacBride the right to enter and 4 occupy the subject parcel of state submerged land, subject to 5 terms including the payment of \$306 monthly rental amount; and 6

7 WHEREAS, the grantee shall pay the State the fair market
8 value of the non-exclusive easement as consideration of the use
9 of public lands, to be determined by an independent appraisal;
10 and

12 WHEREAS, section 171-53, Hawaii Revised Statutes, requires 13 the prior approval of the Governor and prior authorization of 14 the Legislature by concurrent resolution to lease state 15 submerged lands; now, therefore,

17 BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, the 18 House of Representatives concurring, that the Board of Land and 19 Natural Resources is hereby authorized to issue a term, non-20 exclusive easement covering a portion of state submerged lands 21 seaward of the subject property, Hauula, Koolauloa, Oahu, for 22 the existing riprap revetment, ramp, and rock groin, and for 23 use, repair, and maintenance of the existing improvements 24 25 constructed thereon pursuant to section 171-53, Hawaii Revised Statutes; and 26

- TITLE: CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT HAUULA, KOOLAULOA, OAHU, FOR THE EXISTING RIPRAP REVETMENT, RAMP, AND ROCK GROIN, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON.
- PURPOSE: To seek the authorization of the Legislature by concurrent resolution for the issuance of a term, non-exclusive easement by the Board of Land and Natural Resources (Board) for the existing riprap revetment, ramp, and rock groin and for use, repair, and maintenance of the existing improvements constructed thereon.
- MEANS: Concurrent resolution pursuant to section 171-53, Hawaii Revised Statutes (HRS).
- JUSTIFICATION: Portions of the existing riprap revetment, ramp, and rock groin seaward of the property identified as Tax Map Key: (1) 5-3-008:012, Hauula, Koolauloa, Oahu, were placed on state submerged lands.

In August 2022, the Board approved the grant of a 25-year easement to the property owners, Steven Ernest MacBride and Valerie Jean MacBride, as Trustees under that certain unrecorded Steven and Valerie MacBride Revocable Trust dated October 30, 2018, as grantees, for an area of 2,297 square feet including the encroaching riprap revetment, ramp, and rock groin with right, privilege, and authority to construct, use, maintain, and repair the existing seawall. Since that time, the property owners have paid a monthly rental amount of \$306.00 in exchange for the right to occupy and use the premises under a right-of-entry and revocable permit.

The property owners have agreed to pay for an appraisal of the encroachment area by an appraiser selected and contracted by the State of Hawaii to determine the value of the encroachment area and to pay a lump sum in the amount of the appraised value in exchange for a 25-year non-exclusive easement to resolve the encroachments.

The Department's Office of Conservation and Coastal Lands had no objection to the nonexclusive easement to resolve the encroachments.

Section 171-53, HRS, requires the prior approval of the Governor and prior authorization of the Legislature by concurrent resolution to lease state submerged lands. As such, this concurrent resolution has been prepared in compliance with the requirements of section 171-53, HRS.
