## SENATE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A SOCIAL AND FINANCIAL ASSESSMENT OF PROPOSED MANDATORY HEALTH INSURANCE COVERAGE FOR STEP THERAPY REQUIREMENTS FOR STAGE TWO THROUGH STAGE FIVE CANCER.

1 WHEREAS, cancer is a group of diseases characterized by uncontrolled growth and spread of abnormal cells; and 2 3 WHEREAS, cancer is the second leading cause of death in the 4 State, with an average of 7,393 diagnoses of invasive cancer and 5 2,393 deaths annually; and 6 7 WHEREAS, many cancers can be cured if detected and treated 8 9 promptly, and other forms of cancer can be prevented by 10 lifestyle changes; and 11 WHEREAS, breast cancer remains the most frequently 12 diagnosed cancer among women while prostate cancer remains the 13 most frequently diagnosed cancer among men; and 14 15 WHEREAS, disparities in cancer incidence are significant 16 among Native Hawaiians, who have the highest lung cancer 17 incidence and mortality rates, and Filipino women, who have the 18 highest incidence for thyroid cancer; and 19 20 WHEREAS, step therapy is a type of prior authorization that 21 22 requires patients to try a certain, less expensive drug on a health insurance plan that has been proven effective before 23 24 further treatments are authorized; and 25 26 WHEREAS, however, step therapy may limit full access to 27 effective treatment options at early stages of illness; and 28 29 WHEREAS, section 23-51, Hawaii Revised Statutes, requires 30 that "[b]efore any legislative measure that mandates health insurance coverage for specific health services, specific 31

1 diseases, or certain providers of health care services as part of individual or group health insurance policies, can be 2 considered, there shall be concurrent resolutions passed 3 requesting the auditor to prepare and submit to the legislature 4 a report that assesses both the social and financial effects of 5 6 the proposed mandated coverage"; and 7 WHEREAS, section 23-51, Hawaii Revised Statutes, further 8 9 provides that "[t]he concurrent resolutions shall designate a specific legislative bill that: 10 11 Has been introduced in the legislature; and 12 (1) 13 14 (2) Includes, at a minimum, information identifying the: 15 Specific health service, disease, or provider 16 (A) that would be covered; 17 18 Extent of the coverage; 19 (B) 20 (C) Target groups that would be covered; 21 22 23 (D) Limitations on utilization, if any; and 24 25 (E) Standards of care. 26 For purposes of this part, mandated health insurance coverage 27 shall not include mandated optionals."; and 28 29 WHEREAS, section 23-52, Hawaii Revised Statutes, further 30 specifies the minimum information required for assessing the 31 social and financial impact of the proposed health coverage 32 mandate in the State Auditor's report; and 33 34 WHEREAS, Senate Bill No. 2316, introduced in the Regular 35 Session of 2024, proposes to prohibit health insurers that cover 36 treatment for stage two through stage five cancer from the 37 requirement that an insured diagnosed with stage two through 38 stage five cancer to undergo step therapy before covering the 39 40 drug prescribed to the insured by the insured's health care provider, including: 41 42

15 16 17 18 19 20 21	WHEREAS, the Legislature believes that prohibiting health insurers that cover treatment for stage two through stage five cancer from requiring an insured diagnosed with stage two through stage five cancer to undergo step therapy before covering the drug prescribed to the insured by the insured's health care provider will increase the likelihood of proactive treatment of cancer and save lives; now, therefore,
22 23 24 25 26 27 28 29 30 31	BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, the House of Representatives concurring, that the Auditor is requested to conduct an impact assessment report in accordance with sections 23-51 and 23-52, Hawaii Revised Statutes, of prohibiting step therapy requirements in health insurance policies, contracts, plans, or agreements that cover the treatment of stage two through stage five cancer as proposed by Senate Bill No. 2316 (Regular Session of 2024); and
32 33 34 35 36 37 38 39	BE IT FURTHER RESOLVED that the Auditor is further requested to include in its assessment the impact of section 1311(d)(3) of the federal Patient Protection and Affordable Care Act (PPACA) on Senate Bill No. 2316, or similar legislation, that includes but is not limited to the additional cost of any benefits beyond the essential health benefits of Hawaii's qualified health plans under the PPACA; and
40 41 42	BE IT FURTHER RESOLVED that the Auditor is also requested to determine how many qualified health plans are available in

Hawaii, including plans offered by health maintenance 1 organizations; the individual or group enrollment in these 2 3 plans; and the actuarial cost of the defrayment to the State for 4 the prohibition of step therapy requirements for health plans that provide coverage of treatment of stage two through stage 5 five cancer; and 6 7 BE IT FURTHER RESOLVED that the Auditor is requested to 8 submit a report on the Auditor's findings and recommendations, 9 including any proposed legislation, to the Legislature no later 10 than twenty days prior to the convening of the Regular Session 11 of 2025; and 12 13 BE IT FURTHER RESOLVED that certified copies of this 14 Concurrent Resolution be transmitted to the Auditor and 15 Insurance Commissioner, who is requested to transmit copies to 16 each insurer in the State that issues health insurance policies. 17 18 19
