Employment -

I retired from the Department of the Prosecuting Attorney on June 1, 2011, after 28 years.

From June 1983 to June 2011, I worked for the Victim Witness Division of the Department of the Prosecuting Attorney in Honolulu. Rob Luck was the first Director of Victim Witness. Dennis Dunn was the subsequent Director through my retirement. During my years at Victim Witness, I worked under 3 elected Prosecuting Attorneys: Charles Marsland, Peter Carlisle, and Keith Kaneshiro.

As a victim advocate, I advocated on behalf of victims as their cases moved through the Criminal Justice system. I accompanied them to court proceedings and acted as their liaison with the Deputy Prosecuting Attorney. Additionally, I interviewed victims of Domestic Violence, prepared Temporary Restraining Orders, and represented the victim's interests at Civil Hearings, advocated for Restitution and attended Restitution Hearings, and attended Parole Hearings with victims. I also coordinated interviews for sexual assault victims with the Deputy Prosecuting Attorney.

In June 1986, I was promoted to supervise the Misdemeanor Branch of the Victim Witness Division. From 1986 until my retirement, I was fortunate to have supervised every branch of the Victim Witness Division: Intake and Clerical, Misdemeanor, Felony, Sexual Assault and Domestic Violence (both

misdemeanor and felony), and Juvenile Offender Crimes. Besides supervising the Advocates and Clerical Staff who were assigned to these branches, I also carried a full caseload. Additionally, I covered cases that were handled by the Victim Advocate who handled all the Tourist Victim crimes when she was on extended vacation. I represented these branches at interagency meetings as well as meetings with the Department Prosecuting Attorney.

Prior to my 28-year career at the Prosecutor's Office, I was employed doing the following –

September 1973 to March 1975 – District Counseling and Probation – Intake Clerk

August 1974 – May 1978 – Dorm Advisor for 7th and 8th Grade Boarders on the weekends

Summer 1977 – Head Dorm Advisor for the Exploration Program. Supervised a high school graduate student who assisted me. The Exploration Program was for 5th grade boys attending a weekly summer boarding program to have a boarding experience while learnings about Hawaiian culture.

September 1976 to May 30, 1979 – District Court Counseling and Probation – Court Counselor – Interviewed defendants of misdemeanor criminal and traffic offenses. Prepared presentence reports for the Judge. Also supervised defendants placed on probation.
