Your Committee reviewed the personal history, resume, and statement submitted by James Pleiss for service on the Hawaii Board of Chiropractic.

Your Committee received testimony in support of the nomination for the reappointment of James Pleiss from the Hawaii Board of Chiropractic and two individuals.

Upon review of the testimony, your Committee finds that Dr. Pleiss' experience, knowledge, and proven leadership on the Hawaii Board of Chiropractic qualify him for reappointment to the Board as a licensee member. Your Committee notes that Dr. Pleiss has more than forty years of experience as a chiropractor and has been licensed in Hawaii since 1983. Dr. Pleiss currently serves as an examiner for the National Board of Chiropractic Examiners and is also currently active in clinical practice in Wailuku, Maui. Dr. Pleiss is also a board-certified chiropractic orthopedist, one of the few specialties in the chiropractic profession.
