Madame:

Your Committee on Finance, to which was referred H.B. No. 1020, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO A PROGRAM TO CHARACTERIZE CARBON SEQUESTRATION POTENTIAL AND UNDERGROUND WATER RESOURCES STATEWIDE,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Require the Hawaii State Energy Office, in collaboration with the Hawaii Groundwater and Geothermal Resources Center at the University of Hawaii and Director of Business, Economic Development, and Tourism, to implement a Carbon Sequestration and Underground Water Resource Characterization Program and conduct an environmental assessment;
- (2) Require the Hawaii State Energy Office to submit a progress report to the Legislature prior to the Regular Session of 2028; and
- (3) Appropriate funds for the program, including a staff position.
