Madame:

Your Committee on Finance, to which was referred H.B. No. 164, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO INDEBTEDNESS TO THE STATE,"

begs leave to report as follows:

The purpose of this measure is to:

- Require disbursing officers to notify employees within sixty days of determining that an indebtedness has occurred as a result of salary or wage overpayment; and
- (2) Change the amount that a disbursing officer may deduct from an employee's salary, wage, or compensation based on the employee's gross income.

Your Committee received testimony in support of this measure from the United Public Workers, AFSCME Local 646, AFL-CIO; and Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO. Your Committee received comments on this measure from the Department of Accounting and General Services and Hawai'i State Public Library System.
