The purpose of this measure is to appropriate funds to the
Department of Labor and Industrial Relations to supplement the
salary of the State Fire Marshal.

Your Committee received testimony in support of this measure
from the Department of Land and Natural Resources and Lāhainā
Strong.

Your Committee finds that the State Fire Marshal's salary
should be commensurate with the greater responsibilities
contemplated in the Lahaina Fire Incident Analysis Report. Your
Committee believes that this measure addresses this need by
appropriating funds to supplement the salary of the State Fire
Marshal.


Your Committee has amended this measure by changing the
