Madame:

Your Committee on Human Services & Homelessness, to which was referred H.B. No. 280 entitled:

"A BILL FOR AN ACT RELATING TO THE COMMUNITY OUTREACH COURT,"

begs leave to report as follows:

The purpose of this measure is to permanently establish and appropriate funds for the Community Outreach Court as a division of the District Court of the First Circuit.

Your Committee received testimony in support of this measure from the Judiciary; Office of the Public Defender; and Hawaii Substance Abuse Coalition.

Your Committee finds that a Community Outreach Court Program was established in 2017 to assist non-violent offenders who are charged with offenses that disproportionately impact the homeless community by making court attendance more accessible, resolving any active charges, and utilizing alternative sentences such as community service work. Because the Community Outreach Court Program has proven to be successful in helping its participants address legal matters through alternative sentences, this measure would permanently establish the Community Outreach Court, which would allow participants to obtain basic necessities and, if necessary, access to appropriate social services.
