"A BILL FOR AN ACT RELATING TO THE GREEN JOBS YOUTH CORPS," begs leave to report as follows:

The purpose and intent of this measure is to appropriate moneys to the Department of Land and Natural Resources for the continuation of the Green Jobs Youth Corps program.
