Your Committee on Finance, to which was referred H.B. No. 431, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO HOUSING,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Appropriate funds for the continued implementation of the Kauhale Initiative; and
- (2) Create the Supportive Housing Special Fund to assist the Hawaii Housing Finance and Development Corporation to facilitate the development of mixed-income rental housing projects in which some or all the units are targeted to special needs individuals or families who require supportive services.

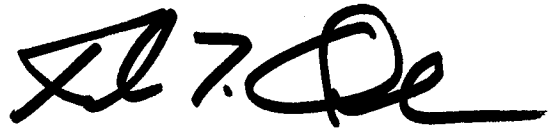
