Your Committee on Finance, to which was referred H.B. No. 749, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO CESSPOOLS,"

begs leave to report as follows:

The purpose of this measure is to:

- Establish a Cesspool Conversion Section within the Department of Health's Wastewater Branch that is dedicated to facilitating the conversion of cesspools within the State; and
- (2) Establish and appropriate funds for positions within the Cesspool Conversion Section.
