Your Committee on Finance, to which was referred H.B. No. 750, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO THE ENVIRONMENT,"

begs leave to report as follows:

The purpose of this measure is to:

- Clarify the authorized uses of the Deposit Beverage Container Deposit Special Fund to include evaluating and promoting recyclable market development activities;
- (2) Require and appropriate funds for the Department of Health to conduct a statewide needs assessment and establish an advisory council with relevant stakeholders to determine what would be needed to transition to a more circular system with less waste generation and more reuse, and the necessary infrastructure to sort and locally process recyclable materials through an extended producer responsibility program for packaging materials and paper products; and
- (3) Require the Department of Health to hold a public hearing on the draft needs assessment and submit the needs assessment to the Legislature by December 31, 2028.


