## Madame:

Your Committee on Finance, to which was referred H.B. No. 756, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO HEALTH,"

begs leave to report as follows:

The purpose of this measure is to prohibit the sale of, offer for sale, or possession with the intent to sell or offer to sell, all flavored nicotine products and nicotine product flavor enhancers, including products with menthol, and prohibit the mislabeling of e-liquid products as nicotine-free.

Your Committee received testimony in support of this measure from the Department of Health; Kailua High School; Kihei Charter School; one member of the Hawai'i County Council; Hawai'i Youth Services Network; Hawai'i Public Health Association; Hawaii Substance Abuse Coalition; Hawai'i State Teachers Association; Parents And Children Together; Kaiser Permanente Hawai'i; Hawai'i Association of Independent Schools; Hina Mauka; Keiki Injury Prevention Coalition; Hawai'i-American Nurses Association; Hawai'i Primary Care Association; Hawaii COPD Coalition; Campaign for Tobacco-Free Kids; Tobacco-Free Kids Action Fund; AlohaCare; The Friends of Kamalani & Lydgate Park; University of Hawaii Student Health Advisory Council; Hawaii Dental Association; Coalition for a Tobacco-Free Hawai'i Youth

Council; Hawai'i Health & Harm Reduction Center; Waianae Coast Comprehensive Health Center; and numerous individuals.

Your Committee received testimony in opposition to this measure from Kainehe Liquor; BMA Mart; ABC Stores; Cigarettes and Things; Bionic Petroleum; China Town Liquor; Cigar Association of America, Inc.; Marukin Market; Retail Merchants of Hawaii; Discount Smoke Shop Hawaii; KCL Aloha Pacific Inc.; No. 1 Store; S&K Wholesale; Nonstop Convenience; Young's Wine & Spirit; Wawa Village Market; Kona Liquor Store; Hawaii Smokers Alliance; Bevmart; Ewa Pantry; Kakaako Smokes; and six individuals.

Your Committee received comments on this measure from the Department of the Attorney General; Tax Foundation; and Taxpayers Protection Alliance.

As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 756, H.D. 2, and recommends that it pass Third Reading.
