Madame:

Your Committee on Judiciary & Hawaiian Affairs, to which was referred H.B. No. 969, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO WASTE OR DISPOSAL FACILITIES,"

begs leave to report as follows:

The purpose of this measure is to prohibit the construction, modification, or expansion of any waste or disposal facility on land that is near or above a significant aquifer, as determined by the Department of Health.

Your Committee received testimony in support of this measure from the Office of Hawaiian Affairs; Honolulu Board of Water Supply; Free Access Coalition; Green Party of Hawai'i; Country Talk Story; Hawai'i Farm Bureau; Hawai'i Reef and Ocean Coalition; International Brotherhood of Electrical Workers Local 1260; Environmental Caucus of the Democratic Party of Hawai'i; Conservation Council for Hawai'i; The Moanalua Gardens Foundation; Justice and Witness Missional Team of the Hawai'i Conference United Church of Christ; Sierra Club of Hawai'i; and numerous individuals. Your Committee received testimony in opposition to this measure from the Office of the Mayor of the County of Maui and Department of Public Works of the County of Kaua'i. Your Committee received comments on this measure from the Department of Health; Department of Environmental Services of the City and County of Honolulu; Energy Justice Network; and Reworld.

Your Committee finds that the State should take preemptive action to minimize the risk of pollution and contamination of water sources, including aquifers. This measure addresses this need by prohibiting the construction, modification, or expansion of any waste or disposal facility on land that is near or above a significant aquifer.

Your Committee has amended this measure by:

- Clarifying what is considered a waste or disposal facility; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity; consistency, and style.

As affirmed by the record of votes of the members of your Committee on Judiciary & Hawaiian Affairs that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 969, H.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as H.B. No. 969, H.D. 2.
