Your Committee on Transportation, to which was referred H.C.R. No. 44 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE HONOLULU AUTHORITY FOR RAPID TRANSPORTATION TO EXTEND THE SKYLINE RAIL PROJECT TO THE WESTSIDE OF O'AHU,"

The purpose of this measure is to request the Honolulu Authority for Rapid Transportation to extend the Skyline rail project to the Westside of O'ahu.

Your Committee received testimony in support of this measure from one individual.

Your Committee finds that the existing route of the Skyline rail project does not adequately serve the growing communities of Nānākuli, Ko 'Olina, Mā'ili, and the Westside of O'ahu. An extension of the project to the Westside of O'ahu will further alleviate traffic congestion and provide an alternative means of egress and ingress to these communities.
