Your Committee on Judiciary & Hawaiian Affairs, to which was referred H.C.R. No. 72 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE ETHICS COMMISSION OF EACH COUNTY TO ADOPT STANDARDS SIMILAR TO THAT APPLICABLE TO STATE ELECTED OFFICIALS AND OFFICERS AS ADOPTED AND ENFORCED BY THE STATE ETHICS COMMISSION,"

The purpose of this measure is that the ethics commission of each county are urged to adopt standards that are applicable to state elected officials and officers as adopted and enforced by the State Ethics Commission.

Your Committee received testimony in support for this measure from four individuals.

Your Committee finds that adopting standards similar to those enforced by the State Ethics Commission will promote transparency, accountability, and ethical conduct at the county level. Ensuring consistent ethical guidelines across state and county levels strengthens public trust and fosters responsible governance by elected officials and officers.
