Your Committee on Transportation, to which was referred H.R. No. 119 entitled:

"HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF TRANSPORTATION SERVICES OF THE CITY AND COUNTY OF HONOLULU TO IMPLEMENT A RESTRICTED PARKING ZONE PILOT PROGRAM IN THE KO 'OLINA, HONOKAI HALE, NĀNĀKULI, AND MAILI NEIGHBORHOODS,"

begs leave to report as follows:

The purpose of this measure is to request the Department of Transportation Services of the City and County of Honolulu to implement a Restricted Parking Zone Pilot Program in the Ko 'Olina, Honokai Hale, Nānākuli, and Maili neighborhoods.

Your Committee received testimony in opposition to this measure from one individual.

Your Committee finds that restricted parking zones are an effective tool for managing on-street parking in residential areas experiencing high demand from non-residents due to nearby traffic generators. The success of the Kalihi Valley Restricted Parking Zone Pilot Program demonstrated significant improvements in parking availability and reduced congestion and unauthorized parking.
