The purpose of this measure is to establish the Veterans Cemeteries Board within the Office of Veterans' Services of the Department of Defense to provide veterans cemeteries in the State with guidance, education, technical assistance, and other support to ensure compliance with standards set by the National Cemetery Administration of the United States Department of Veterans Affairs.

Your Committee received testimony in support of this measure from the Office of Veterans' Services and one individual.

Your Committee has amended this measure by:

- (1) Changing its effective date to July 1, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 1377, S.D. 2, as amended herein, and recommends that it pass Third Reading in the form attached hereto as S.B. No. 1377, S.D. 2, H.D. 1.
