Your Committee on Finance, to which was referred S.B. No. 264, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE EXAMINATION OF CRIMINAL DEFENDANTS,"

begs leave to report as follows:

The purpose of this measure is to establish the amount of compensation for private sector examiners who evaluate a criminal defendant's penal responsibility or fitness to proceed in a legal case and appropriate funds to the Judiciary for these payments.

Your Committee received testimony in support of this measure from the Judiciary; one member of the Kaua'i County Council; Hawai'i Psychological Association; and Hawaii Disability Rights Center. Your Committee received comments on this measure from the Department of Health and Office of the Public Defender.

Your Committee has amended this measure by changing the effective date to July 1, 3000, to encourage further discussion.
