Your Committee on Ways and Means, to which was referred S.B. No. 325 entitled:

"A BILL FOR AN ACT RELATING TO THE GENERAL FUND,"

begs leave to report as follows:

The purpose and intent of this measure is to dispose of excess general fund revenues pursuant to Article VII, section 6 of the State Constitution.

Specifically, this measure:

- Provides for an income tax credit to every qualifying resident individual taxpayer of the State;
- Makes an unspecified deposit into the emergency and budget reserve fund established pursuant to section 328L-3, Hawaii Revised Statutes; and
- (3) Makes an unspecified deposit into the other postemployment benefits trust fund established pursuant to section 87A-42, Hawaii Revised Statutes.

Your Committee received comments on this measure from the Department of Taxation and Tax Foundation of Hawaii.
