Your Committee on Ways and Means, to which was referred S.B. No. 40, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO STATE FINANCES,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the Hawaii Housing Finance and Development Corporation to utilize revenue bonds when securing the line of credit for the Bond Volume Cap Recycling Program.

Your Committee received written comments in support of this measure from the Hawaii Housing Finance and Development Corporation.

Your Committee finds that the Hawaii Housing Finance and Development Corporation needs a line of credit to provide liquidity for private activity bond recycling. Your Committee also finds that the line of credit will help provide financial stability to the Corporation for its financing structure, which will ensure efficiency in its financial operations.

Your Committee has amended this measure by changing the effective date to July 1, 2050, to facilitate further discussion on the measure.
