Your Committee on Ways and Means, to which was referred S.B. No. 443, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO AGRICULTURAL LANDS,"

The purpose and intent of this measure is to require lands within the agricultural land district that have solar energy facilities to obtain certification from the Department of Agriculture that the lands are also used for farming operations.

Your Committee received written comments on this measure from the Department of Agriculture and State Energy Office.

Your Committee believes that this measure will balance the State's renewable energy needs with its interest in preserving productive agricultural lands.
