Your Committees on Ways and Means and Judiciary, to which was referred S.B. No. 716, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HAWAII EMPLOYMENT SECURITY LAW,"

beg leave to report as follows:

The purpose and intent of this measure is to increase efficiency and fairness of the Hawaii employment security law.

Specifically, this measure:

- Repeals the requirement for unemployed individuals to (1) make their work availability accessible online in order to qualify for unemployment benefits;
- (2) Expands the circumstances for which the Department of Labor and Industrial Relations may waive the requirements for eligible individuals to register to work and report to an employment office;
- Requires notices of determinations and documentation (3) relating to appeals to be sent electronically, unless the election for mail is made; and
- Allows an individual to change an elected withholding (4) status more than once during a benefit year.
