 - a. Operating Engineers Local 3 was instrumental in creating HMOAB, and had always had a representative on the board, representing the workers that operate cranes for a living in Hawaii.

 - a. My role and responsibility are the same as the board. We are charged with establishing minimum standards to assure construction tower and crane operators across the islands operate hoisting machines in a safe and lawful manner on behalf of the citizens of our State.
3. Given your understanding of the role and responsibilities of a member of the Hoisting Machine Operators Advisory Board, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Hoisting Machine Operators Advisory Board.
 - a. I have been a crane operator and have kept my NCCCO and HIOSH card current for the past 20 years. I've operated various cranes and have field knowledge of it's capabilities and limitations. Currently I am a Business Agent for Operating Engineers Local 3. I have the opportunity to meet and visit with crane operators on different jobsites. I believe with my field experience and relationships with other crane operators will help me in my role and responsibilities on the Board.
4. What do you hope to accomplish during your term of service?
 - a. My first task was to help the board hire and executive director and work on the backlog of certifications that needed to get out to applicants.
 - b. Moving forward I would like to work with my fellow board members to ensure all standards are up-to-date, practical, and ensure safety for the public.
5. Name three qualities that best describe you and that would make you stand out.
 - a. I will listen to all sides before making my decision.
 - b. I am always willing to discuss my position on things with others.
 - c. I will always ask questions if I don't know something until I understand it.
6. How would these qualities benefit the Hoisting Machine Operators Advisory Board?
 - a. I feel these qualities will allow me to work well with my fellow board members and answer questions that crane operators out in the construction field may have regarding requirements set by the board.
7. Name one pervious experience that would make you stand out. How would this benefit the Hoisting Machine Operators Advisory Board?
 - a. A few months ago a local 3 member who previously let his NCCCO expire was told by his employer to operate a crane. He called seeking advise for fear

of losing his job. I recommended to him not operate the crane because he is no longer certified and the Union will protect his employment.

8. Can you foresee any possible conflicts of interests that could arise during your service on the Hoisting Machine Operators Advisory Board? How would you overcome any possible conflicts of interest?

- a. I do not see any possible conflicts of interest, but if I feel there is an conflict I will automatically consult with the Hawaii State Ethics Commission.
- b. I am also looking forward to the comprehensive ethics training all commission and board members are required to receive.
