Aloha Ann Young:

Congratulations on your nomination to the Emergency Medical Services Advisory Committee. To assist the Hawaii State Senate with its confirmation process, we request that you submit the following information to our office no later than February 21st, 2025, to ensure that we proceed in a timely manner:

1. Why do you wish to be a member of the Emergency Medical Services Advisory Committee.

I wish to be a member of this Committee because I believe that civil service by caring citizens is essential to a well-functioning, democratic society and I would like to play my part. EMSAC is charged with the vital task of overseeing the state's emergency services programs, which responds to the emergency needs of the acutely injured and ill. While my day job entails directly serving the children of Hawaii by treating them in the emergency department, a Committee role allows for broader stewardship of our state's emergency care infrastructure. By becoming a member of this committee, I hope to effect positive change to the emergency infrastructure by improving the pediatric readiness of our state's emergency resources, which in turn will save children's lives.

2. What do you perceive are the roles and responsibilities of a member of the Emergency Medical Services Advisory Committee.

As the pediatric representative on EMSAC, my roles and responsibilities include attending and participating in the quarterly board meetings, communication with the directors and front-line workers in Hawaii's EMS departments, collaborating with other board members on committee projects, and providing pediatric emergency expertise where it is needed. I have already reviewed and provided feedback on the pediatric EMS protocols that each EMS crew uses when they treat pediatric patients in the field. I also plan to help with new pediatric-specific innovations and educational initiatives through Emergency Medical Services for Children, whose meetings I also attend.

3. Given your understanding of the roles and responsibilities as a member of the Emergency Medical Services Advisory Committee, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.

As a practicing, board-certified pediatric emergency medicine physician with an interest in community medical education, I possess the specific skills and desire necessary to sit on this committee. I am one of 15 practicing board-certified pediatric emergency medicine physicians who practice at Hawaii's only pediatric tertiary care hospital, Kapi'olani Medical Center for Women and Children. I have undergone rigorous medical training, beginning with medical school at Baylor College of Medicine in Houston, TX, where I was then recruited to general pediatric residency at Texas Children's Hospital. TX. While training to become a general pediatrician, I remained connected to the local community through my volunteer work as a Pediatric Advanced Life Support Instructor and a simulation educator for the Houston Fire Department. I helped lead training sessions for paramedics to improve their pediatric skills, including hands-on case practice in high-pressure, low-occurrence field situations. I received numerous teaching awards for my service. I was inspired to pursue a career in pediatric emergency medicine after seeing the positive and life-changing impact of this field. I completed my 3-year fellowship in pediatric emergency medicine at Boston Children's Hospital, where I continued to serve with the local Boston Fire Department EMS crews through helping lead their annual paramedic pediatric simulation trainings and was also selected to serve as Chief Fellow of my fellowship program. My research during fellowship focused on pediatric readiness in general emergency departments in the United States. Taken together, my training, expertise, and continued passion for improving pediatric emergency care at all levels has equipped me to be a member of EMSAC.

- 4. What do you hope to accomplish during your term of service? I hope to improve the pediatric readiness of our local EMS crews and general hospitals. I hope to ensure that our EMS pediatric protocols provide EMS crews with practical, safe, and effective interventions to power them to diligently care for children during emergencies and save lives. I hope to partner with our local Kapiolani Community College Paramedic training program for pediatric case reviews and to provide emergency pediatric simulation trainings.
- 5. Name three qualities that best describe you and how these qualities will the Emergency Medical Services Advisory Committee.
 Three qualities that describe me include: 1) Integrity 2) Humility 3) Diligence. As a person of integrity, I seek to make wise decisions for the good of those around me, regardless of if I am being watched. At times, doing the right thing is difficult, but with integrity, I will have the courage to do what is always right. Having integrity as a

physician and as an EMSAC board member is essential, as we are charged with caring for the vulnerable, as well as the oversight of the emergency care of our state, and we should never abuse that power. I will also assess any issues EMSAC faces with clarity and not shy from fixing things that need to be fixed. As a person of humility, I understand that great things are done together, through community. While I am confident in my skills and training, I also know that I always have something more to learn, and that each person offers their own unique point of view, which enriches our collective understanding. I seek the wisdom of others and do not wish to repeat the mistakes of the past. As a person of diligence, I understand the value of hard work and of leaving no stone unturned. Oversight at a state level entails a high level of care and excellence, starting with the small decisions. I believe that my high level of diligence serves me well in this role, as I will be a person who is reliable and keeps my promises.

- 6. Name a previous experience you've had that will be beneficial as a member. My current job as a pediatric emergency medicine physician at Kapiolani Medical Center for Women and Children provides me with essential experience that will benefit me as an EMSAC member. I am at the beating heart of the highest level of pediatric emergency care on the island. Every shift, I regularly interact with EMS crews who come in from the field, receiving their calls, providing real-time medical advice over the phone, and overseeing the transfer of patient care from the pre-hospital to the hospital environment. I believe that this practical experience gives me insight into the situations that EMS front-line workers experience. I deliberately debrief sick patients with EMS crews and provide real-time feedback on their care. This helps me understand their level of training and gaps in their knowledge that need to be addressed.
- 7. Can you foresee any possible conflicts of interest that could arise during your service on the Emergency Medical Services Advisory Committee. How would you overcome conflicts of interest?

I do not foresee any conflicts of interest. If I were to have any conflicts of interest, I would immediately report them to the EMSAC chair.
