1. Why do you wish to be a member of the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances?

As a Native Hawaiian committed to the wellbeing of our communities, I believe serving on this commission is an opportunity to elevate culturally grounded approaches to addressing substance use and behavioral health. Our people have been disproportionately impacted by colonization and systemic inequities. I want to ensure that policies and programs reflect the lived experiences, strengths, and cultural wisdom of our communities. This seat allows me to advocate for healing-centered strategies rooted in connections to Hawaii.

As the Community Education representative, and commission Co-Chair, I am also deeply committed to advocating for increased education around culturally responsive care for *all* of the diverse communities who call Hawai'i home. I believe we must provide education and guidance to strengthen systems of care that are culturally safe, trauma-informed, and rooted in respect for the unique histories and worldviews of every community impacted by substance use and behavioral health challenges.

2. What do you perceive are the roles and responsibilities of a member of the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances?

Members of the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances play a critical role in supporting the Department of Health and advising state leadership on substance use-related matters. Our responsibilities include:

- Assisting the Department of Health in coordinating action programs among community agencies to address alcohol and drug use;
- Helping to carry out educational programs aimed at preventing and deterring substance use;
- Creating public awareness and fostering understanding of the impacts of alcohol and drug use;
- Serving in an advisory capacity to the Governor, Director of Health, and other state departments on matters related to substance use and recovery;
- Supporting the development and review of the State plan for alcohol and other substance use;
- Providing input necessary for securing and managing federal funding for substance use programs;

• Preparing an annual report to the Governor summarizing the Commission's work and recommendations for legislation.

In fulfilling these duties, members are responsible for staying informed on current and emerging practices in prevention, harm reduction, treatment, recovery, and aftercare, while offering community-centered, culturally informed perspectives that shape the direction of substance use policy in Hawai'i.

3. Given your understanding of the roles and responsibilities as a member of the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.

My qualifications are rooted in both lived experience and professional practice in behavioral health, substance use, and culturally grounded systems of care. I currently serve as the Program Coordinator for Papa Ola Lōkahi's substance use and mental health initiatives, and as the Project Manager for the SAMHSA-funded 'Ohana Center of Excellence for AANHPI Behavioral Health. In these roles, I lead the development of training, curriculum, and policy guidance that uplift cultural strengths, center healing, and respond to the disproportionate impacts of substance use and mental health concerns within Native Hawaiian and Pacific Islander communities.

A culturally focused lens is essential to addressing the root causes of substance use and promoting sustainable healing in Hawai'i. Approaches that center Indigenous values, place-based knowledge, practice-based evidence, and relational care offer not only relevant frameworks for Native Hawaiian communities, but also meaningful pathways for systemic change across all communities. My experience with cultural models, through program development, education, and policy work, brings a critical perspective to the Commission's responsibilities. These approaches align with broader efforts to re-center healing, promote culturally safe systems of care, and ensure that communities most impacted by substance use are accurately represented and equitably resourced. Sharing this knowledge at the Commission level helps ensure that recommendations are grounded in the lived realities of Hawai'i's diverse populations.

My work is intentionally intersectional, engaging reentry, housing justice, workforce development, harm reduction, and peer-led recovery, while keeping cultural identity at the center. Through years of collaboration with both local and national partners, I've built strong pilina across government agencies, nonprofits, and community-based organizations. These relationships, combined with my experience in training, federal grant

management, legislative advocacy, and systems change, position me to serve as a bridge between policy systems and the people they are intended to support.

4. What do you hope to accomplish during your term of service?

During my term, I hope to:

- Uplift Indigenous and cultural knowledge systems as valid and necessary foundations for addressing substance use;
- Address disparities in access to care for Native Hawaiians and Pacific Islanders by advocating for culturally focused healing programs;
- Explore the development of recovery community organizations that center culture as a source of identity, belonging, and transformation;
- Support education and training efforts to ensure that providers across Hawai'i are equipped to deliver or connect with an organization/practitioner that can provide culturally responsive and culturally safe care;
- Serve as a bridge between community voices and policy decision-makers, ensuring that the lived experiences, solutions, and requests of our communities are reflected in statewide strategies.

Above all, I want to be a voice.

5. Name three qualities that best describe you and how these qualities will benefit the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances.

Grounded: rooted in culture, community, and relationships to 'āina, ensuring that every recommendation I make is aligned with collective wellbeing and cultural responsibility.

Collaborative: pilina—building meaningful relationships across disciplines, sectors, and cultural communities—to promote collaboartion in our collective work.

Strategic: I try to approach challenges with both a systems-level and community-centered lens, identifying opportunities to shift structures in ways that honor culture and support long-term healing.

6. Name a previous experience you've had that will be beneficial as a member.

My role as Project Manager for the 'Ohana Center of Excellence has given me the opportunity to develop culturally focused trainings for health and behavioral health providers across the country. In doing so, I have worked closely with communities across

the AANHPI spectrum to uplift the unique strengths, communication styles, and worldviews of each culture. Our trainings help providers understand not only cultural etiquette and historical context, but also the deep complexities—including regional differences, layered identities, and forced migration—that shape an individual's experience with care.

This experience has strengthened my ability to build education that fosters empathy, accuracy, and safety in care delivery, an essential lens I hope to bring to my work on the Commission.

7. Can you foresee any possible conflicts of interest that could arise during your service on the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances? How would you overcome conflicts of interest?

Given my professional role coordinating culturally focused behavioral health and substance use projects, there may be times when the council would want to hear a presentation about a project that I help oversee. In such cases, I would ensure that another member of my organization or an external representative speaks on the matter.

I am fully committed to transparency, accountability, and ethical integrity. I will follow all protocols, disclose potential conflicts proactively, and seek guidance from appropriate legal or administrative advisors when necessary.
