1. Why do you wish to be a member of the Emergency Medical Services Advisory Committee.

I am already a member (accidentally placed in the Allied Health seat instead of the MICT seat in 2021). As a working Mobile Intensive Care Technician (MICT), I feel that it is critical that the issues we see on the road are shared with the Emergency Medical Service Advisory Committee (EMSAC).

2. What do you perceive are the roles and responsibilities of a member of the Emergency Medical Services Advisory Committee.

I will/do raise awareness of Maui County specific issues and see how they overlap with the other counties. There is a tendency to focus on Oahu (due to population levels there), but Maui County has very specific issues due to being a three-island county that has challenging Emergency Medical Service logistics.

3. Given your understanding of the roles and responsibilities as a member of the Emergency Medical Services Advisory Committee, why do you believe that you are qualified for the position? (Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.)

I already sit on the board. I have been collaborating with other MICT's in all the counties, in order to identify any overlapping issues. I am well versed in the issues DOH requires for this seat and the challenges of the Sunshine Law that governs our communications.

My qualifications come from 11 years on the road, while also serving as Kapiolani College staff for the EMS training department. I've collaborated with the US Coast Guard to develop a Diving Safety Worksheet to assist the EMS crews when they receive patients from the dive community. Over the last decade, I served as a primary crew member on Maui Medevac Rotor, stepping up when the HLF plane crash happened. We also cover the entire state for air transfers.

I have a deep dedication and commitment to EMSAC, which can be seen over the last 4 years through my public speaking. I have been the squeaky wheel when contract issues for Maui and Kauai County deeply affected all of the Emergency Medical Service Road crews. I will always speak my truth.

4. What do you hope to accomplish during your term of service?

Getting Maui County working radios with emergency call buttons that operate well, to keep everyone on the road as safe as possible.

5. Name three qualities that best describe you and how these qualities will the Emergency Medical Services Advisory Committee.

- passionate about my work and the community I serve.

- Well versed in the challenges of being a rural county that consists of three islands and only one trauma center.

6. Name a previous experience you've had that will be beneficial as a member.

I am a current board member as well – so this will mean continuing participation on this important Board.
