Gubernatorial Nominee Raymond Mamea

The State Council on Developmental Disabilities (DD) STRONGLY SUPPORTS GM609 to confirm the nomination of Raymond Mamea for a term to expire June 30, 2028.

The Council's Federal mandate (P.L.106-402 - DD Assistance and Bill of Rights Act of 2000) is clear in determining the composition of this body to ensure that all the stakeholders are represented and engaged in the development and implementation of a comprehensive system of services and supports for individuals with DD. The Governor's Nominee meets all the Federal Requirements for Council membership.

He is an active member of our Self Advocate Advisory Council and has participated in our annual day at the capitol events.
